

SPECIAL MEETING OF THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:

JUNE 26, A.D.1920, at 9.30 A.M.

PRESENT: Honorable Sam C. Bell, Mayor, and Commissioners Coy, Heuermann and Wright.

This meeting was called for the purpose of hearing the evidence on charges filed by A.J.Goetz, Chief of the Fire Department of the City.of San Antonio against the following members of the Fire Department of said City, to-wit: W.
