APPOINTING BRENT R. ANDERSON (PRIMARY REPRESENTATIVE, CATEGORY: COMMERCIAL BUILDING OWNER OR MANAGER REPRESENTATIVE) AND CHRISTIE P. STREICHER (ALTERNATE REPRESENTATIVE, CATEGORY: COMMERCIAL BUILDING OWNER OR MANAGER REPRESENTATIVE) TO THE BUILDING-RELATED AND FIRE CODES APPEALS AND ADVISORY BOARD AND WAIVING THE CITY CODE RESIDENCY REQUIREMENT IN CHAPTER 2, ARTICLE IX, SEC. 2-529(B) FOR MS. STREICHER'S APPOINTMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Brent R. Anderson (Primary Representative, Category: Commercial Building Owner or Manager Representative) and Christie P. Streicher (Alternate Representative, Category: Commercial Building Owner or Manager Representative) to the Building-Related and Fire Codes Appeals and Advisory Board for the remainder of unexpired terms of office to expire May 31, 2013.


SECTION 2. The residency requirement in Section 2-529 (b) of the City Code is waived for this appointment for Ms. Streicher.


