

AN ORDINANCE 2007-02-01-0125

AUTHORIZING ACCEPTANCE OF A FY2007 LOAN STAR LIBRARIES GRANT AWARD IN THE AMOUNT OF \$87,187.00 FROM THE TEXAS STATE LIBRARY AND ARCHIVES COMMISSION TO BE USED FOR REPLACING OUTDATED PUBLIC DESKTOP COMPUTER WORKSTATIONS THROUGHOUT THE SAN ANTONIO PUBLIC LIBRARY SYSTEM.

WHEREAS, the Loan Star Libraries grant award program provides direct state aid for Texas public libraries to improve public library services statewide and ensure access to adequate public library resources for all Texans; and

WHEREAS, the San Antonio Public Library has received authorization to accept Loan Star Library funds since FY2002; and

WHEREAS, previous Loan Star Libraries grants have been used to establish core digital video disk (DVD) collections in all library locations, to purchase replacement desktop computers for use at most library locations throughout the city and to replace obsolete laptop equipment in the Library's mobile computer lab; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee or the Director of the Library Department is authorized to accept a FY2007 Loan Star Libraries grant award in the amount of \$87,187.00 from the Texas State Library and Archives Commission to be used for replacing outdated public desktop computer workstations throughout the San Antonio Public Library system for a term beginning September 1, 2006 and ending August 31, 2007. The City Manager or her designee or the Director of the Library Department is further authorized to execute the grant award contract attached hereto and incorporated herein for all purposes as Attachment I.

Section 2. Fund 26018000 entitled "Texas State Library" and Internal Order 104000000033 entitled "Lone Star Grant 2007", are hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant.

Section 3. The budget, which is attached hereto and incorporated herein for all purposes as Attachment II, is approved and adopted for entry in the City books.

The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall be effective on and after February 11, 2007.


