

AN ORDINANCE 2013-04-04-0234

AUTHORIZING THE AMENDMENT AND MONTH TO MONTH EXTENSION OF A CONTRACT WITH GONZABA MEDICAL GROUP FOR THE ADMINISTRATION AND MANAGEMENT OF THE CITY'S EMPLOYEE HEALTH AND WELLNESS CENTER FOR A PERIOD OF NO LONGER THAN FOUR (4) MONTHS, AND AN AMOUNT NOT TO EXCEED \$140,000.00, WHICH IS THE AMOUNT BUDGETED FOR THE CENTER FUNDED IN THE EMPLOYEE BENEFITS FUND.

WHEREAS, the City of San Antonio and Gonzaba Medical Group entered into an agreement pursuant to Ordinance No. 2008-05-01-0354, under which Gonzaba Medical Group provides administration and management of the City's Occupational Health and Wellness Center which includes drug testing, pre-employment physicals, job related vaccinations, care for employee illness and injury, and ancillary onsite services; and

WHEREAS, the cost for the Contract Amendment is an estimated amount of \$140,000.00; and

WHEREAS, the parties now wish to amend the term of the contract as set forth in the attached agreement; and

WHEREAS, the parties now wish to execute a month-to-month extension to begin May 1, 2013, on an as-needed basis, and expire no later than August 31, 2013; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City's Occupational Health and Wellness Center Contract with Gonzaba Medical Group is hereby amended to extend the contract on a month-to-month basis, from May 1, 2013 through no later than August 31, 2013, as set for the in Attachment 1. The City Manager, or her designee, is authorized to execute said Amendment and Extension. The terms of the Amendment and Extension are hereby approved.

SECTION 2. Funding for this Ordinance is contingent upon budget appropriation in the Employee Benefits Fund 75002000, Cost Center 1002050001 Wellness, General Ledger 5201040, Fees For Professional Contractors.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


SECTION 4. This Ordinance is effective immediately if passed by eight (8) affirmative votes; otherwise this Ordinance is effective ten (10) days after passage.





**AMENDMENT AND EXTENSION OF PROFESSIONAL SERVICES CONTRACT
FOR ADMINISTRATION AND MANAGEMENT OF THE OCCUPATIONAL HEALTH AND
WELLNESS CENTER**

This Amendment and Extension of the Professional Services Contract for Administration and Management of the Occupational Health and Wellness Center (the "Contract") is entered into by and between the City of San Antonio ("City") and Gonzaba Medical Group ("Vendor"), and as follows:

I. AMENDMENT AND EXTENSION


Contract Section VI, Term, is amended to allow for extension of said contract on a month to month basis at City's request, beginning May 1, 2013, and not to exceed August 31, 2013. This Extension will allow City to complete the Request for Proposals review process. City hereby extends the term of said Contract for a month to month basis under the same terms and conditions as stated in said Contract and as amended herein.

II. PROVISIONS REMAIN IN EFFECT

All other current terms, conditions, covenants and provisions of the Contract approved through Ordinance No. 2012-05-03-0329; No. 2008-05-01-0354 and as previously amended by Ordinance No. 2010-09-02-0755, not specifically mentioned herein and revised by this document, are hereby retained in their entirety, unchanged, and shall remain in full force in effect for the duration of said Contract.
