

AN ORDINANCE 2010-01-21-00481

**AUTHORIZING A TEN-YEAR FOOD AND BEVERAGE CONCESSION AGREEMENT WITH EDWIN ENTERPRISES, INC. TO OPERATE A CHARLEY'S GRILLED SUBS AT SAN ANTONIO INTERNATIONAL AIRPORT TERMINAL B WITH MINIMUM ANNUAL GUARANTEED RENTALS TOTALING \$442,050.00. IN YEARS 1 THROUGH 5.**

**WHEREAS**, the City issued a Request for Proposals on July 26, 2009 for the operation of two sit-down dining restaurants and four food court locations in Terminal B of San Antonio International Airport ("Airport");

**WHEREAS**, the evaluation committee, recommended for contract award the proposal submitted by Edwin Enterprises, Inc. for a Charley's Grilled Subs concept; and

**WHEREAS**, it is in the best interest of the City to enter into a food and beverage concession agreement with Edwin Enterprises, Inc. as recommended by the evaluation committee; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is hereby authorized to execute a ten-year standard food & beverage concession agreement with Edwin Enterprises, Inc. for the operation of a Charley's Grilled Subs in Airport Terminal B – Food Court Space #2 with guaranteed rentals totaling \$442,050.00 in years 1 through 5.

**SECTION 2.** The revenue from this contract will be deposited in SAP Fund 51001000, Internal Order 233000000128, and General Ledger 4409034.


**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.




