AN ORDINANCE

36148

AUTHORIZING THE EXECUTION OF CERTAIN INSURANCE CONTRACTS BY THE CITY OF SAN ANTONIO WITH THE AMERICAN AND FOREIGN INSURANCE COMPANY, THE COMMERCIAL UNION INSURANCE COMPANY, AND THE GLOBE INDEMNITY COMPANY, AND AUTHORIZING THE PAYMENT OF INSURANCE PREMIUMS IN THE AGGREGATE SUM OF \$1,977.00

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:--

1. The City Manager is hereby authorized and directed to execute contracts required in connection with insurance policies for the New Main Library Building and Contents as follows:

- a. Fire and Extended Coverage Policy, for the period December 29, 1967 to May 31, 1970, which will provide coverage for loss or damage by windstorm, hurricane, hail, explosion, riot, civil commotion, smoke, aircraft and land vehicles. Coverage will be for \$1,600,000, 80% co-insurance applicable.  
Premium: \$1,495.00
- b. Comprehensive General Liability Policy, for the period January 1, 1968 to August 1, 1968, with limits of \$20,000 each person and \$40,000 each accident for bodily injury, and \$5,000 each accident for property damage. Provides coverage for premises operations.  
Premium: \$107.00
- c. Comprehensive General Liability Policy, for the period January 1, 1968 to August 1, 1968, with limits of \$50,000 each person and \$300,000 each accident for bodily injury. Provides coverage for operation of elevators.  
Premium: \$143.00
- d. Boiler and Machinery Policy, for the period January 1, 1968 to August 1, 1968, which will provide coverage for damages to boilers due to accidents and resulting damages to the building housing the equipment. To the extent of indemnity remaining, coverage provides for damages to property of others and for bodily injury. Accident limit: \$500,000.  
Premium: \$19.00
- e. Comprehensive Glass Policy, for the period January 1, 1968 to August 1, 1968, which will provide coverage for breakage of seventeen ceramic light fixtures, and plate glass.  
Premium: \$213.00

2. That payments of insurance premiums required on policies described hereinbefore, are hereby authorized as follows:

- a. The sum of \$1,495.00 to the Brussels Insurance Agency, 408 Gunter Building, San Antonio, Texas
- b. The sum of \$269.00 to Fred W. Riley, Milam Building, San Antonio, Texas
- c. The sum of \$213.00 to the L. C. Beery Insurance Agency, 419 Camden Street, San Antonio, Texas
