

AN ORDINANCE 2011-05-12-0388

AUTHORIZING THE EXPANSION OF THE INNER CITY REINVESTMENT INFILL POLICY (ICRIP) BOUNDARY.

WHEREAS, in an effort to promote inner-city growth and economic development, the City Council approved the Inner City Reinvestment Infill Policy (ICRIP) in February of 2010; and

WHEREAS, the policy provides for certain fee waivers and other economic incentives and has stimulated economic activity within the current ICRIP boundary; and


WHEREAS, City staff has evaluated the policy and recommends expanding the current boundary to include adjacent areas where economic growth and revitalization are needed; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council hereby approves the expansion of the ICRIP Boundary as described in Exhibit A. Exhibit A shall replace any existing boundary maps and shall serve as the ICRIP Boundary Map from the effective date of this Ordinance.


