

AN ORDINANCE 2012-06-21-0516

AUTHORIZING A CONTRACT AMENDMENT TO A PROFESSIONAL SERVICES AGREEMENT FOR HEAD START DENTAL SERVICES WITH MICHELLE LANDRUM, R.D.H. TO INCREASE THE COMPENSATION BY \$53,000.00 BRINGING THE NEW CUMULATIVE AMOUNT TO \$161,832.00 AND EXTENDING THE TERM THROUGH SEPTEMBER 30, 2013.

WHEREAS, the San Antonio Metropolitan Health District (Metro Health) operates two public health outreach program dental clinics that provide diagnostic and preventive dental care and case management services for low-income children; and

WHEREAS, on an annual basis, Metro Health's oral health outreach program serves more than 13,000 children by bringing services to non-traditional location; and

WHEREAS, through operation of its school-based sealant program, Metro Health provides diagnostic and preventive care for more than 7,000 economically disadvantaged elementary school-aged children utilizing portable dental equipment; and

WHEREAS, Metro Health's Dental Division currently operates an oral health outreach program for all children enrolled in Head Start San Antonio and Bexar County and infants, children and expectant mothers participating in Head Start San Antonio and Bexar County; and

WHEREAS, oral health assessment preventive care, including fluoride varnish applications and case management services, are provided for more than 6,800 children enrolled in Head Start programs in Bexar County; and

WHEREAS, a registered dental hygienist, Ms. Landrum provides both direct patient care and consultation services including preventive care, case management, and oral health education for children and expectant mothers enrolled in local Head Start and Early Head Start programs; and

WHEREAS, the additional \$53,000.00 in compensation will allow Ms. Landrum to continue to provide critical child dental health services, bringing the new cumulative amount of the contract to \$161,832.00 and extending the term through September 30, 2013 in order to align her agreement with other Metro Health contracted service providers; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or his designee is authorized to execute an amendment to a professional services agreement for Head Start dental services with Michelle Landrum, R.D.H. to increase the compensation by \$53,000.00 bringing the new cumulative amount to \$161,832.00 and extending the term through September 30, 2013. A copy of the amendment in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Fund 2602236032 entitled "Head Start Dental 2012" and Internal Order 136000000555, are hereby designated for use in the accounting for the fiscal transaction in the authorization of this agreement.

SECTION 3. The sum of \$53,000.00 is hereby appropriated in the above designated fund and will be disbursed from 5201040 "Fees to Professionals". Payment is authorized to Michelle Landrum, R.D.H. upon issuance of purchase orders.


SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.



AMENDMENT #1

The City of San Antonio, (“CITY”) entered into an agreement (“AGREEMENT”) with Michelle Landrum (“CONTRACTOR”) on June 1, 2010 for the provision of public health dental hygienist services. CITY now wishes to amend the AGREEMENT so as to increase compensation and extend the term of the period of services for the purpose of sustaining current patient demands, and hereby agrees to amend the AGREEMENT as follows:

II. TERM

2.1 Unless sooner terminated in accordance with the provisions of this Agreement, the term of this Agreement shall commence on June 1, 2010 and terminate on September 30, 2013.

IV. COMPENSATION TO CONTRACTOR

4.1 In consideration of Contractor’s performance in a satisfactory and efficient manner, as determined solely by Director, of all services, activities, duties and responsibilities set forth in this Agreement, City agrees to pay Contractor a fee of \$38.00 per hour, up to an amount not to exceed one hundred sixty one thousand eight hundred and thirty two dollars (\$161,832.00) for the term of this Agreement

All of the other terms and conditions of said contract shall remain in full.
