AN ORDINANCE *MP-1116*

APPROPRIATING \$425,803.42 OUT OF THE 1938 GENERAL FUND TO PAY SEVENTEEN (17) NOTES NOS. 42 TO 58, INCLUSIVE, AND INTEREST

BE IT ORDAINED by the Commissioners of the City of San Antonio, that, the sum of \$425,803.42, be and the same is appropriated hereby out of the 1938 General Fund to pay Seventeen Notes Nos. 42-43-44-45-46-47-48-49-50-51-52-53-54-55-56-57-58 of the 1938 General Fund Series, \$25,000.00, each, maturing on or before June 30, 1939, and \$803.42 accrued interest, payable as follows:
