APPROPRIATING \$48.59 FROM THE 1932 GENERAL FUND, STREET MAINTENANCE DEPARTMENT, TO PAY THE RATABLE SHARE OF INTEREST TO ACQUIRE CERTAIN PROPERTY IN NEW CITY BLOCKS 1445, 1446 and 1448, TO WIDEN AND EXTEND EAST COMMERCE STREET.

BE IT ORDAINED by the Commissioners of the City of San Antonio, that,

1.
