AMENDING AN ORDINANCE PASSED AND APPROVED ON THE 24TH DAY OF SEPTEMBER, A.D. 1942, ENTITLED "AN ORDINANCE APPROPRIATING \$7,989.56 OUT OF VARIOUS SINKING FUNDS IN PAYMENT OF OCTOBER 1, 1942 BOND AND COUPON MATURITIES AND EXPENSES".

BE IT ORDAINED BY THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:-

1. That an ordinance entitled "AN ORDINANCE APPROPRIATING \$ 7,989.56 OUT OF VARIOUS SINKING FUNDS IN PAYMENT OF OCTOBER 1, 1942 BOND AND COUPON MATURITIES AND EXPENSES", passed and approved by the Commissioners of the City of San Antonio on the 24th day of September, A.D. 1942, be and the same is hereby amended so that the appropriation of \$1,789.56 payable to Frost National Bank out of Water Improvement District No. 6, be appropriated in payment to Bexar County Water Control and Improvement District No. 6, and Appropriation No. 236, of September 24, 1942, is hereby changed to conform herewith.
