

AN ORDINANCE 2007-03-29-0345

**AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED *JESSE GONZALES V. CITY OF SAN ANTONIO*, IN THE 225TH JUDICIAL DISTRICT COURT, BEXAR COUNTY, TEXAS, CAUSE NO. 2003-CI-17227, FOR THE AMOUNT OF \$95,000.00**

**WHEREAS**, on December 23, 2003, Plaintiff Jesse Gonzales filed a lawsuit against the City of San Antonio based on allegations of wrongful termination by the City; and,

**WHEREAS**, the City of San Antonio has vigorously asserted that the Plaintiff's employment termination was completely justified and legal; however, it is in its best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and,

**WHEREAS**, the Plaintiff has agreed to accept total payment from the City of San Antonio in an amount of \$95,000.00 payable to Jesse Gonzales, and his attorney, Matthew R. Pearson, as full and final settlement of this lawsuit; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1:** The amount of \$95,000.00 is authorized to be paid from Fund 75-001000, Insurance Reserve, from GL 5402530, entitled General Liability Claims, in Cost Center 1009020001, and is authorized to be made payable to Jesse Gonzales and his attorney Matthew R. Pearson, for settlement of the lawsuit styled *Jesse Gonzales v City of San Antonio*, Cause No. 2003-CI-17227.

**SECTION 2:** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific cost centers and fund numbers as necessary to carry out the purpose of this ordinance.


**SECTION 3.** This ordinance shall be effective on the tenth day after passage hereof.
