APPROPRIATING \$80.00 TO PAY C. E. BARTHOLOMAE.

1. That the sum of \$80.00 be and the same is hereby appropriated out of the 1939 General Fund-Police Account, to be paid to C. E. Bartholomae upon said C. E. Bartholomae executing a release and acquittance to the City of San Antonio of all debts, demands, liabilities and causes of action whatever claimed by said C. E. Bartholomae on account of salary and vacation pay during the period from August 16th, 1939 to August 31st, 1939, said appropriation being to replace check no. 1771 and warrant no. 326 heretofore issued to C. E. Bartholomae, which check and warrant are hereby in all things cancelled and declared null and void.
