---MEMORIALS AND PETITIONS---

Petition of Carrie Satel for special building permit was read and referred to Building Inspector.

AN ORDINANCE *MD-823*

Appropriating \$50,541.67 to pay note of the City, with interest.

BE IT ORDAINED by the Commissioners of the City of San Antonio, that, the sum of \$50,541.67 be and the same is hereby appropriated out of the 1919 General Fund to pay note of the City numbered 31, held by the Alamo National Bank, to-wit:

AN ORDINANCE *- 824*

Transferring certain funds to 1919 General Fund.

BE IT ORDAINED by the Commissioners of the City of San Antonio:

Section 1: That the sum of \$10,000.00 be and the same is hereby appropriated out of the Bak Tax Fund for transfer to 1919 General Fund.

Section 2. That the sum of \$12,000.00 be and the same is hereby appropriated out of the 1919 General Fund for transfer to 1919 General Fund; and that the City Auditor is hereby directed to make the proper entries on the records of his office evidencing said transfers.

AN ORDINANCE *- 824.1*

Transferring funds from General Interest Fund to General Sinking Fund.

BE IT ORDAINED by the Commissioners of the City of San Antonio, that, the sum of \$6000.00 be and the same is hereby appropriated out of the General Interest Fund for transfer to General Sinking Fund, and the City Auditor is hereby directed to make the said transfer on the records of his office.

AN ORDINANCE *- 825*

Refunding certain taxes collected from F.A.Piper in error.

BE IT ORDAINED by the Commissioners of the City of San Antonio, that, the sum of \$37.05 be and the same is hereby appropriated out of the hereinafter named funds to pay F.A.Piper on account of double assessment of property (the San Antonio School Boards proportion being \$8.97)

settlement of/damages sustained by him by reason of the widening of Losoya Street and
the surrender by him of all rights claimed on the Schulz property on said street.
