**AUTHORIZING THE RENAMING OF “KONO ROAD” TO “LEON THOMAS WAY” BETWEEN THE CROSS-STREETS OF “GEMBLER ROAD” AND “BELGIUM LANE.”**

**WHEREAS**, an application was submitted through the United Homeowners Improvement Association for consideration of a proposal to rename “Kono Road” to “Leon Thomas Way” between the cross-streets of “Gembler Road” and “Belgium Lane;” and

**WHEREAS**, notice of said proposal was disseminated through public service announcements and postings at City Hall, Council believes that the purpose for and input provided by the City Code procedures for renaming streets has been satisfied; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The city-owned street known as “Kono Road” located in City Council District 2 between the cross-streets of “Gembler Road” and “Belgium Lane” is hereby renamed “Leon Thomas Way.” City staff is directed to provide appropriate signage to this effect.


**SECTION 2.** There is no financial impact realized through the passage of this Ordinance.

**SECTION 3.** This Ordinance shall be effective on the 10<sup>th</sup> day of April, 2011.




