

SPECIAL MEETING OF THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:

FRIDAY, NOVEMBER 13TH, A. D. 1936, 9:00 A. M.

PRESENT: Honorable Phil Wright, Acting Mayor, presiding, and Commissioners, Bushick, Rubiola, Steffler. Absent Hon. C. K. Quin. Mayor.

The Clerk read the following call, to-wit:-

San Antonio, Texas.

To The Commissioners of the
City of San Antonio.

Gentlemen:-

Under the authority vested in me by the Charter of the City of San Antonio, I hereby call you in Special Session on this the 13 day of November, A. D. 1936, to convene at 9:00 o'clock A. M., to canvass the returns of the Special Election held on the 12 day of November, A. D. 1936, when propositions to borrow money on the credit of the City of San Antonio and issue bonds of the City therefor, as follows:-

"A - FIRE STATION 2 BUILDINGS BONDS, \$100,000.00;
B - POLICE AND FIRE STATION BONDS, \$60,000.00; C- HEALTH BUILDING BONDS, \$12,000.00; D- STINSON AIRPORT BONDS, \$30,000.00; E - AUDITORIUM BONDS \$6,000.00; F- PARK IMPROVEMENT BONDS, \$12,000.00; G - ZOOLOGICAL GARDEN BONDS, \$20,000.00; H- MARKET SHEDS BONDS, \$85,000.00; I - SAN PEDRO CREEK IMPROVEMENT BONDS, \$2,000.00; J- BRIDGE CONSTRUCTION BONDS, \$30,000.00; K- STREET IMPROVEMENT BONDS \$45,000.00; L- SEWER CONSTRUCTION BONDS, \$48,000.00";

were submitted to the qualified voters of the City of San Antonio, for their adoption or rejection, as in the call for said election stipulated, as required by the Charter of the City of San Antonio.

A RESOLUTION

DECLARING THE CANVASS AND THE RESULTS OF A SPECIAL ELECTION ON THE 12 OF NOVEMBER 1936 TO SUBMIT TO THE QUALIFIED VOTERS WHO OWN TAXABLE PROPERTY IN SAID CITY AND WHO HAVE DULY RENDERED THE SAME FOR TAXATION, TWELVE SEPARATE PROPOSITIONS TO BORROW MONEY ON THE CREDIT OF THE CITY AND TO ISSUE BONDS OF THE CITY FOR PERMANENT PUBLIC IMPROVEMENTS IN AND FOR SAID CITY, AS FOLLOWS:- (A) FIRE STATION 2 BUILDING BONDS, \$100,000.00; (B) POLICE AND FIRE STATION BONDS, \$60,000.00; (C) HEALTH BUILDING BONDS, \$12,000.00; (D) STINSON AIRPORT BONDS, \$30,000.00; (E) AUDITORIUM BONDS, \$6,000.00; (F) PARK IMPROVEMENT BONDS, \$12,000.00; (G) ZOOLOGICAL GARDEN BONDS, \$20,000.00; (H) MARKET SHEDS BONDS, \$85,000.00; (I) SAN PEDRO CREEK IMPROVEMENT BONDS, \$2,000.00; (J) BRIDGE CONSTRUCTION BONDS, \$30,000.00; (K) STREET IMPROVEMENT BONDS, \$45,000.00; (L) SEWER CONSTRUCTION BONDS \$48,000.00.

BE IT RESOLVED BY THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:-

1. Came on regularly to be canvassed, on this the 13 day of November, 1936, the day after the special election to borrow money on the credit of the City of San Antonio and to issue bonds of the City for permanent public improvements in and for said City, the returns of the special municipal election held on the 12 day of November, 1936, at which election there was submitted to the

qualified voters who own taxable property in said City and who have duly rendered the same for taxation, twelve separate propositions to borrow money on the credit of the City and to issue bonds of the City for permanent public improvements in and for said City as fully set out in the Ordinance ordering said election passed and approved on the 13 day of October 1936, and as set out in the Proclamation and Notice of Election promulgated by the Mayor on the 13 day of October 1936, posted at the several voting places in the 105 precincts in said City and published in the San Antonio Light, as required by law, and the Mayor and Commissioners having met to canvass the returns and to declare the result of said election in the manner provided by law, and after considering, determining and canvassing all the matters of fact thereto appertaining; and,

2. WHEREAS, said returns were canvassed by the Commissioners of the City of San Antonio, and the result of said election declared at their meeting held in the Council Chamber at the City Hall in said City, on the 13 day of November 1936, from which it appears that said Proposition A to issue \$100,000.00 Fire Station 2 Building Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election, and that said Proposition B to issue \$60,000.00 Police and Fire Station Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election, and that said Proposition C to issue \$12,000.00 Health Building Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election, and that Proposition D to issue \$30,000.00 Stinson Airport Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election, and that Proposition E to issue \$6,000.00 Auditorium Bonds of the City of San Antonio was not approved by a majority of the qualified voters voting at said election, and that Proposition F to issue \$12,000.00 Park Improvement Bonds of the City of San Antonio was not approved by a majority of the qualified voters voting at said election, and that Proposition G to issue \$20,000.00 Zoological Gardens Bonds of the City of San Antonio was not approved by a majority of the qualified voters voting at said election, and that Proposition H to issue \$85,000.00 Market Sheds Bonds of the City of San Antonio was not approved by a majority of the Qualified voters voting at said election, and that Proposition I to issue \$2,000.00 San Pedro Creek Improvement Bonds of the City of San Antonio was not approved by a majority of the qualified voters voting at said election, and that Proposition J to issue \$30,000.00 Bridge Construction Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election and that Proposition K to issue \$45,000.00 Street Improvement Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election, and that Proposition L to issue \$48,000.00 Sewer Construction Bonds of the City of San Antonio was approved by a majority of the qualified voters voting at said election, the respective votes cast in favor of and against said Proposition to issue bonds of the City of San Antonio, as appears from said returns, and said canvass, being as follows, to-wit:-

And it appearing to the Board of Commissioners that said proposition to issue bonds of the City were submitted and that the special election was held and was conducted as required by the Statutes of the State of Texas and the Charter and Ordinances of the City of San Antonio; and, that at said special election there was cast on each proposition submitting a proposition to borrow money on the credit of the City of San Antonio and to issue bonds for permanent public improvements, the aggregate number of votes marked "FOR" and the aggregate number of votes marked "AGAINST", all as shown by the report and the canvass of said returns by the Board of Commissioners, and said returns having been found to be correct in all respects, it is declared that Proposition A to issue \$100,000 Fire Station 2 Building Bonds was adopted by a majority vote, that Proposition B to issue \$60,000 Police and Fire Station Bonds was adopted by a majority vote, that Proposition C to issue \$12,000 Health Building Bonds was adopted by a majority vote, that Proposition D to issue \$30,000 Stinson Airport Bonds was adopted by a majority vote, that Proposition E to issue \$6,000 Auditorium Bonds was not adopted by a majority vote, that Proposition F to issue \$12,000 Park Improvement Bonds was not adopted by a majority vote, that Proposition G to issue \$20,000 Zoological Gardens Bonds was not adopted by a majority vote, that Proposition H to issue \$85,000 Market Sheds Bonds was not adopted by a majority vote, that Proposition I to issue \$2,000 San Pedro Creek Improvement Bonds was not adopted by a majority vote, that Proposition J to issue \$30,000 Bridge Construction Bonds was adopted by a majority vote, that Proposition K to issue \$45,000 Street Improvement Bonds was adopted by a majority vote, and that Proposition L to issue \$48,000 Sewer Construction Bonds was adopted by majority vote, of the qualified voters at said election.

4. PASSED AND APPROVED AND ADOPTED this the 13 day of November, A. D. 1936.
