

A RESOLUTION **2010-04-08-0019R**

**SUPPORTING THE RANDOLPH AIR FORCE BASE JOINT LAND USE
STUDY COORDINATED BY BEXAR COUNTY.**

WHEREAS, the 2005 Defense Base Realignment and Closure Commission (BRAC) recommendations proposed significant changes to the military missions in San Antonio and the surrounding area, including those performed at Randolph Air Force Base (RAFB) which is located to the northeast of the City; and

WHEREAS, the implementation of the BRAC recommendations, coupled with ongoing growth in Bexar County and San Antonio, make it necessary to conduct a Joint Land Use Study (JLUS) to ensure Randolph AFB's continued mission readiness and effectiveness to support our country's national security, and

WHEREAS, a JLUS will address encroachment affecting base operations, flight training, and aviation noise management issues around RAFB, the Seguin Auxiliary Field and Military Training Routes and the land below the Military Operating Areas, and

WHEREAS, Bexar County is sponsoring the JLUS by submitting a grant application to the Office of Economic Adjustment and acting as the JLUS coordinator; and

WHEREAS, Bexar County has requested a Resolution of Support from the City to include in its application; and

WHEREAS, this Resolution will signify the City's support and commitment to the JLUS and to make a good faith effort to enact recommendations pertaining to the City to preserve and protect the missions at Randolph AFB; **NOW THEREFORE:**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council of the City of San Antonio supports a Joint Land Use Study coordinated by Bexar County for the area surrounding Randolph Air Force Base.


SECTION 2. This Resolution shall be effective on and after the tenth (10th) day after passage.






