

AN ORDINANCE 2010-12-16-1098

AUTHORIZING THE ADDITION OF THE HONORARY STREET SIGN "ST. PADRE PIO PARKWAY" TO EXISTING SIGNS ON BULVERDE PARKWAY BETWEEN THE CROSS STREETS OF BULVERDE ROAD AND BLUE TRINITY.

* * * * *

WHEREAS, over the last two years, St. Padre Pio Catholic Church (Church) has experienced a significant increase in visitors making pilgrimages to the only national shrine to St. Padre Pio. St. Padre Pio Catholic Church is currently housed in a 20,000 sq. ft. building and experience weekly visitations of 2,500 plus patrons during the conducting of their four (4) masses; and

WHEREAS, the Church's administration forecasts an exponential increase in patrons as they move towards construction of a 1,500 seat replica of the Patron Saints Church located in Italy. This increase in human activity is further compounded by the planned construction of an on-site Catholic School; and

WHEREAS, visitors are confused by the street signs, Bulverde Road and Bulverde Parkway. The Church is requesting consideration of the placement of an honorary street name, St. Padre Pio Parkway, in order to alleviate this confusion of visitors traveling to the Church's parish located between the cross streets of Bulverde Road and Blue Trinity and to honor the Patron Saint of the Parish; **NOW THEREFORE**,


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Bulverde Parkway between the cross streets of Bulverde Road and Blue Trinity is hereby given the honorary name of the "St. Padre Pio Parkway". City staff is directed to provide appropriate signage to this effect. **Exhibit 1** is attached showing the impacted street location.

SECTION 2. There is no financial impact realized through the passage of this Ordinance.

SECTION 3. This Ordinance shall be effective on the 26th day of December, 2010.






