AN ORDINANCE (1389)

APPROPRIATING \$ 100,037.04 OUT OF 1942 GENERAL FUND TO PAY FOUR (4) NOTES NOS. 1 TO 4 INCL. OF THE 1942 GENERAL FUND SERIES.

BE IT ORDAINED by the Commissioners of the City of San Antonio, that, the sum of \$100,000.00, be and the same is hereby appropriated out of 1942 General Fund (Various Departments) payable to Frost National Bank of San Antonio, Texas to pay Four (4) Notes Nos. 1 to 4 incl. of the 1942 General Fund Series, \$ 25,000.00 each, maturing on or before July 1, 1942;

AND, the sum of \$ 37.04, be and the same is hereby appropriated out of 1942 General Fund (Interest Department) to pay accrued interest on 1942 General Fund Notes Nos. 1 to 4 incl.
