AN ORDINANCE **81 52 1**

NAMING THE DURANGO STREET BRIDGE IN HONOR OF FORMER COUNCILMAN JOE WEBB (DISTRICT TWO) AS REQUESTED BY COUNCILWOMAN RUTH JONES McCLENDON.

WHEREAS, former Councilman Joe Webb served honorably on the City Council for fourteen years, and was instrumental in bringing many improvements to District Two, which he served faithfully; and

WHEREAS, Councilman Webb also contributed his talents and energies toward other efforts to improve life within District Two, being active in such civic organizations as the YMCA, the NAACP, Project Free, his school district and his church; and

WHEREAS, it is fitting to honor such dedication in the naming public facilities; and

WHEREAS, Rev. R.A. Callies, Sr. and the Youth Leadership Conference for Community Progress submitted a formal request that the City name the Durango Street Bridge in honor of Joe Webb; and

WHEREAS, the City Council believes it would be proper and right to do so in recognition of Councilman Webb's work on behalf of the public; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

That the Durango Street bridge over the railroad system, located just south of the Alamodome, between Hoefgen and Cherry Streets, is hereby named the Joe Webb Bridge. City staff shall erect appropriate signage to evidence this designation.
