

AN ORDINANCE **2011-08-18-0671**

APPOINTING DAVID L. JURECZKI (DISTRICT 8) TO THE BUILDING STANDARDS BOARD FOR A TERM OF OFFICE TO COMMENCE JANUARY 1, 2012 AND TO EXPIRE MAY 31, 2013 AND WAIVING THE CITY CODE RESIDENCY REQUIREMENT IN CHAPTER 2, ARTICLE IX, SEC. 2-529(B) FOR THIS APPOINTMENT.

WHEREAS, in May of 2011, City Council amended the City Code, Chapter 6, Article VIII "Dangerous Building and Distressed Properties," and created the Building Standards Board to hear and resolve San Antonio Property Maintenance Code cases as well as dangerous buildings or structures cases; and

WHEREAS, the Building Standards Board consists of fourteen (14) total members, with district appointments accounting for ten members and at large appointments accounting for the remaining four; and

WHEREAS, it is necessary to appoint members to the Building Standards Board; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. David L. Jureczki (District 8) is appointed to the Building Standards Board for a term of office to commence January 1, 2012 and to expire May 31, 2013.


SECTION 2. The City Code residency requirement in Chapter 2, Article IX, Sec. 2-529(b) is waived for this appointment.

SECTION 3. This Ordinance shall become effective on the 1st day of January, 2012.




