AN ORDINANCE 41891

REVISING AND ESTABLISHING ELECTION PRECINCTS
FOR THE CITY OF SAN ANTONIO, TEXAS.

* * * *

WHEREAS, the Bexar County Tax Assessor-Collector has informed the City Clerk that it will be physically impossible for his office to furnish Voter Registration lists based upon precincts established by the Commissioners' Court in 1972, which would be effective March 1, 1973, and

WHEREAS, the existing Voter Registration lists are those that correspond to the election precincts established by the Commissioners' Court of Bexar County, Texas pursuant to the authority invested in them by law, on the 16th day of August, 1968, the 15th day of August, 1969, the 14th day of August, 1970, and the 13th day of August, 1971, and

WHEREAS, in order to conduct a proper and orderly election and give all qualified voters in the City of San Antonio an opportunity to vote in the forthcoming City election, it will be necessary to use the election precincts which correspond to the existing Voter Registration lists; NOW, THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. That the following voting precincts within the corporate limits of the City of San Antonio shall be after March 1, 1973, identical precincts as revised, established and corrected by the Commissioner's Court of Bexar County, State of Texas, as promulgated by the Orders on the 16th day of August, 1968, the 15th day of August, 1969, the 14th day of August, 1970, and the 13th day of August, 1971, which Orders are included herein by reference as fully and to all intents and purposes as if they were copied herein, the said voting precincts being numbered as follows: 101 to 144 inclusive, 157, 158, 201 to 243 inclusive, 245 to 248 inclusive, 252, 258, 259, 260, 261, 301 to 312 inclusive, 314 to 319 inclusive, 326 to 335 inclusive, 338 to 348 inclusive, 350, 361, and 401 to 437 inclusive.

SECTION 2. Those portions of Bexar County Election Precincts now within the City Limits of the City of San Antonio are hereby established as City Voting Precincts as follows:

- (a) That portion of Bexar County Election Precinct No. 147 now within the City Limits of San Antonio is established as City Voting Precinct No. 147.
- (b) That portion of Bexar County Election Precinct No. 159 now within the City Limits of San Antonio is established as City Voting Precinct No. 159.
- (c) That portion of Bexar County Election Precinct No. 249 now within the City Limits of San Antonio is established as City Voting Precinct No. 249.
- (d) That portion of Bexar County Election Precinct No. 251 now within the City Limits of San Antonio is established as City Voting Precinct No. 251.

- (e) That portion of Bexar County Election Precinct No. 262 now within the City Limits of San Antonio is established as City Voting Precinct No. 262.
- (f) That portion of Bexar County Election Precinct No. 351 now within the City Limits of San Antonio is established as City Voting Precinct No. 351.
- (g) That portion of Bexar County Election Precinct No. 356 now within the City Limits of San Antonio is established as City Voting Precinct No. 356.

SECTION 3. Those portions of Bexar County Voting Precincts Numbers 146, 145, 255, 257, 358, 359, 361 and 438 within the limits of the City of San Antonio are hereby combined with adjacent City Precincts as follows:

- (a) City Voting Precinct No. 136 is hereby enlarged to include that part of Bexar County Election Precinct No. 146 located within the City Limits of San Antonio, Texas.
- (b) City Voting Precinct No. 144 is hereby enlarged to include that part of Bexar County Election Precinct No. 145 located within the City Limits of San Antonio, Texas.
- (c) City Voting Precinct No. 260 is hereby enlarged to include that part of Bexar County Election Precinct No. 255 located within the City Limits of San Antonio, Texas.
- (d) City Voting Precinct No. 261 is hereby enlarged to include that part of Bexar County Election Precinct No. 257 located within the City Limits of San Antonio, Texas.
- (e) City Voting Precinct No. 342 is hereby enlarged to include that part of Bexar County Election Precinct No. 358 located within the City Limits of San Antonio, Texas.
- (f) City Voting Precinct No. 338 is hereby enlarged to include that part of Bexar County Election Precinct No. 359 located within the City Limits of San Antonio, Texas.
- (g) City Voting Precinct No. 316 is hereby enlarged to include that part of Bexar County Election Precinct No. 361 located within the City Limits of San Antonio, Texas.
- (h) City Voting Precinct No. 434 is hereby enlarged to include that part of Bexar County Election Precinct No. 438 located within the City Limits of San Antonio, Texas.

SECTION 4. There is filed herewith a map reflecting and describing all of the hereinabove described precincts which map and the descriptions shown thereon are hereby adopted and made a part of this ordinance.
