AN ORDINANCE **74057**

APPOINTING LYNDA BILLA BURKE TO FILL THE  
UNEXPIRED CITY COUNCIL TERM OF HELEN DUTMER  
COUNCIL DISTRICT 3, WHO HAS RESIGNED; AND  
DECLARING AN EMERGENCY.

WHEREAS, Councilwoman Helen Dutmer, District 3 representatives on the City Council, has submitted her resignation; and

WHEREAS, pursuant to City Charter Section 8, a vacancy on the Council is to be filled by a majority vote of the remaining members for the unexpired term; and

WHEREAS, the City Council has received the suggestion from the outgoing Councilmember that LYNDA BILLA BURKE be named as her replacement; and

WHEREAS, the suggestion has been considered, it has been found that LYNDA BILLA BURKE possesses all qualifications required for the office and it is believed she will be an efficient and knowledgeable member of this body; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The resignation of HELEN DUTMER as Councilmember from District 3, effective August 2, 1991, is hereby accepted.

SECTION 2. LYNDA BILLA BURKE is hereby appointed as a member of the City Council, Place No. 3, to serve for the remainder of the unexpired term of Helen Dutmer.

SECTION 3. Because the citizens of District 3 should not be without representation on the Council, an emergency is declared so that this ordinance and the appointment made hereby shall be effective immediately upon passaged hereof.
