

AN ORDINANCE **61890**

AMENDING ORDINANCE NO. 61730 (CANVASS OF FLUORIDE ELECTION) BY CORRECTING DISCREPANCIES OF THE PRESIDING JUDGES' RETURN SHEETS FOUND IN A RECHECK OF VOTING MACHINES TALLIES IN PRECINCTS 1052, 2042, 3049, 4036 AND 4054.

WHEREAS, Ordinance No. 61730 of November 7, 1985 canvassed the returns and declared the results of a Referendum Election held on November 5, 1985, on an ordinance providing for fluoridation of the City's water supply; and

WHEREAS, there were discrepancies in the Presiding Judges' return sheets found in a recheck of their tallies in the following precincts:

WHEREAS, City Council now desires to amend Ordinance No. 61730 so as to correct the tally of the final vote; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. That Ordinance 61730 of November 7, 1985, which canvassed the returns and declared the results of a Referendum Election held on November 5, 1985, providing for fluoridation of the City's water supply is hereby amended so as to correct the tally of the final vote as follows:

39,050	Votes for the Ordinance
42,323	Votes Against the Ordinance

SECTION 2. The above corrections are necessary because of the addition errors in the return sheets which were found in a recheck of the voting machine tallies.




