AN ORDINANCE **89295**

AMENDING ORDINANCE NO. 89159, PASSED AND APPROVED ON JANUARY 28, 1999, ORDERING THE REGULAR MUNICIPAL ELECTION TO BE HELD ON THE 1ST DAY OF MAY, 1999, TO RELOCATE ONE EARLY VOTING SITE IN DISTRICT 8.

WHEREAS, the City Council of the City of San Antonio on January 28, 1999, enacted Ordinance No. 89159, ordering the May 1, 1999, Regular Municipal Election; and

WHEREAS, an attachment to that ordinance is a list of Early Voting sites for balloting to be held April 14-27, 1999; and

WHEREAS, this Amendment will provide a more convenient Early Voting site to persons in newly-annexed areas as well as other voters in City Council District 8; **NOW THEREFORE:**


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. That the Temporary Branch Early Voting site at the Sun Harvest Market, 8101 Callaghan Road in City Council District 8, be deleted from the listing of Early Voting sites for the May 1, 1999, Regular Municipal Election, and


That, in its place, an Early Voting site be designated at Ultramar Diamond Shamrock Corporation Headquarters, 6000 N. Loop 1604 West, also in Council District 8.





SUBJECT: Amendment to Early Voting Site List

DATE: February 9, 1999

SUMMARY:

In order to provide a more convenient Early Voting site to persons in newly-annexed areas, as well as to other voters in City Council District 8, it is recommended that the previously-approved Temporary Branch Early Voting site at Sun Harvest Market, 8108 Callaghan Road, be deleted, and in its place designate Ultramar Diamond Shamrock Corp. headquarters, 6000 N. Loop 1604 West, also in Council District 8.

BACKGROUND:

For a number of years, one of the designated Temporary Branch Early Voting sites for both City and County elections was the Diamond Shamrock headquarters building in The Colonnade, at IH 10 West and Wurzbach Road. When the firm moved into its new headquarters on Loop 1604, the site was shifted to Sun Harvest Market at 8101 Callaghan Road, in the same area. With the annexation of substantial areas along IH 10 West, and the population grown in the overall area, it was felt that a Temporary Branch Early Voting site further to the north in Council District 8 would be appropriate.

FINANCIAL IMPACT:

None.

POLICY ANALYSIS:

This recommended change is in keeping with City policy of providing the most convenient Early Voting sites for voters in municipal elections.

RECOMMENDATION:



COORDINATION:



THIS ORDINANCE IS BEING PROPOSED IN ORDER TO PROVIDE A MORE CONVENIENT EARLY VOTING SITE TO PERSONS IN NEWLY-ANNEXED AREAS, AS WELL AS TO OTHER VOTERS IN CITY COUNCIL DISTRICT 8, AND IT IS RECOMMENDED THAT THE PREVIOUSLY-APPROVED TEMPORARY BRANCH EARLY VOTING SITE AT SUN HARVEST MARKET, 8108 CALLAGHAN ROAD, BE DELETED, AND IN ITS PLACE DESIGNATE ULTRAMAR DIAMOND SHAMROCK CORPORATION HEADQUARTERS, 6000 N. LOOP 1604 WEST, ALSO IN COUNCIL DISTRICT 8.
