

AN ORDINANCE 2008 - 02 - 07 - 0100

AUTHORIZING THE EXECUTION OF A CONTRACT AMENDMENT WITH SOUTHWEST GENERAL HOSPITAL, L.P. D/B/A SOUTHWEST GENERAL HOSPITAL INCREASING THE MAMMOGRAPHY SERVICES AGREEMENT FROM \$125,000.00 TO \$139,111.00 FOR THE PERIOD MAY 1, 2005 THROUGH JUNE 30, 2007 IN ORDER TO CLOSE FINAL BILLING RELATED TO THIS GRANT AND SERVICES PROVIDED.

WHEREAS, the City, through the San Antonio Metropolitan Health District (SAMHD), receives funding through various grants to provide screening and diagnostic mammography services to uninsured low-income women of San Antonio; and

WHEREAS, the SAMHD program targets women who do not have insurance, are low income, or may not have access to information and screening; and

WHEREAS, the program also focuses on breaking barriers to education and detection of breast cancer by providing referral, follow-up, coordination, explanation of procedures, access to transportation, and interventions that assist women with abnormal findings until a diagnosis can be made; and

WHEREAS, the professional diagnostic services provided by Southwest General Hospital (SWG) allow SAMHD clients to receive appropriate diagnostic evaluations and subsequent treatment; and

WHEREAS, an increase in the contract is necessary because SWG was able to serve more clients than anticipated during the contract period; and

WHEREAS, the contract is being amended to close final billing related to this grant and services provided; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the San Antonio Metropolitan Health District or his designee, is authorized to execute a contract amendment with Southwest General Hospital, L.P. d/b/a Southwest General Hospital increasing the Mammography Services agreement from \$125,000.00 to \$139,111.00 for the period May 1, 2005 through June 30, 2007 in order to close final billing related to this grant and services provided. A copy of the contract amendment is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. Fund 26012000 entitled Misc. Agencies and Internal Order 136000000336 entitled Komen Breast Cancer Screen 2006-07, are hereby designated for use in the accounting

for the fiscal transaction in the amending of the Funding Agreement with Southwest General Hospital, L.P. d/b/a Southwest General Hospital.

SECTION 3. The sum of \$14,111.00 is hereby appropriated in the above designated fund and will be disbursed from GL 5201040 entitled Fees to Professional Contractors. Payment is authorized to Southwest General Hospital, L.P. d/b/a Southwest General Hospital.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 5. This ordinance shall be effective on and after February 17, 2008.



AMENDMENT TO MAMMOGRAPHY SERVICES AGREEMENT

Amendment No. 2

The City of San Antonio, ("City") entered into an Agreement ("Agreement") with Southwest General Hospital, L.P. d/b/a Southwest General Hospital, a Delaware Limited Partnership (hereinafter referred to as "SWG"), on July 1, 2004 as a provider of Mammography Services. On October 5, 2006 the agreement was amended to increase the compensation and extend the contract period. City now wishes to amend the Agreement so as to adjust the compensation, for the purpose of sustaining current patient demands, and hereby agrees to amend the AGREEMENT.

Article III. Section 3.2 is hereby replaced with the following:

III. FEES

3.2 SWG understands that the total reimbursement for services provided under this AGREEMENT will not exceed \$55,000.00 for the period July 1, 2004 through April 30, 2005. SWG further understands that the total reimbursement for services provided under this AGREEMENT will not exceed \$139,111.00 for the period May 1, 2005 through June 30, 2007. Mammography and interpretation services to women presenting a written referral from the CITY will be charged no additional fees.

All of the other terms and conditions of said contract shall remain in full force and effect. Executed this 6th day of March 2008.


