

AN ORDINANCE **53648**

DECLARING THE RESULTS OF THE CANVASS OF MUNICIPAL RUNOFF ELECTION HELD ON THE 18TH DAY OF APRIL, 1981.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council convened on this 20th day of April, 1981, to canvass the returns of the runoff municipal election held on the 18th day of April, 1981, to determine the members of the Council, Place No. 1 and Place No. 10, of the City of San Antonio for the ensuing term of office of two years.

SECTION 2. The City Council has met to canvass the returns and to declare the results of said election in the manner provided by law, and after considering, determining and canvassing all matters of fact appertaining, we, the City Council of the City of San Antonio, do hereby find and declare the results of the said election to be tabulated as follows:

FOR MEMBER OF COUNCIL, PLACE NO. 1:

- "FOR" Alfonso "Al" Peeler 3,035 votes
- "FOR" Maria Antonietta Berriozabal. . . 3,761 votes

FOR MEMBER OF COUNCIL, PLACE NO. 10:

- "FOR" James C. Hasslocher 5,002 votes
- "FOR" Tommy Guy Cude. 1,576 votes

SECTION 3. The names of the candidates were submitted and the election was held and conducted and the returns thereof were made, all as required by the City Charter, the laws of the State of Texas and the proclamation of the Mayor, and at said runoff election there were cast respectively for each of said candidates the number of votes shown above.

SECTION 4. The City Council having canvassed said returns and having found the same in all things correct, the canvass was thereupon adopted by a majority vote of the members of the Council of the City of San Antonio; and it is declared that as the result of said runoff election, the elected officers of the City of San Antonio, for Council Place No. 1 and for Council Place No. 10, for the two years commencing on the 1st day of May, 1981, is as follows:

- Member of Council, Place 1:
 - Maria Antonietta Berriozabal;
- Member of Council, Place 10:
 - James C. Hasslocher.
