WHEREAS, pursuant to the provisions of Sec. 19 of Art. 7.14 V.A.T.S., a petition in writing by twenty-five resident citizens of the City of San Antonio has been made and presented to the City Council requesting a re-canvassing of the official returns of the election of April 2, 1957, for Councilmen for the City of San Antonio; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

1. That the City Attorney be and is hereby directed and authorized to petition a district court in the County of Bexar for an order to open and check each and every voting machine used in the election on April 2, 1957, hereinabove referred to, by comparing the votes actually recorded on each of said machines on each of the candidates for the City Council of the City of San Antonio against the official returns forwarded to the City Clerk by the proper election officials in the various designated precincts.
