

AN ORDINANCE **97520**

AMENDING ORDINANCE NO. 97210, PASSED ON FEBRUARY 13, 2003, TO REFLECT CHANGES IN POLLING SITES TO BE USED IN THE MAY 3, 2003 REGULAR AND JOINT ELECTION; EFFECTIVE IMMEDIATELY IF PASSED BY AT LEAST EIGHT (8) VOTES.

WHEREAS, Ordinance No. 97210 passed and approved on February 13, 2003, sets the polling sites to be used in the May 3, 2003 Regular and Joint Election; and

WHEREAS, a number of polling sites must now be changed due to the unavailability of several sites; and

WHEREAS, it is now necessary to amend Ordinance No. 97210 to reflect changes in polling sites to be used in the May 3, 2003 Regular and Joint Election; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 97210, passed and approved on February 13, 2003, is hereby amended to reflect the changes in the polling sites in the May 3, 2003 Regular and Joint Election in accordance with **Exhibit A**, which contains a revised list of polling sites and is attached hereto and is incorporated herein for all purposes.



SUMMARY AND RECOMMENDATION

This ordinance will amend Ordinance No 97210 passed on February 13, 2003 to reflect changes in polling sites as outlined in Attachment A.

BACKGROUND INFORMATION

Attached is a list of 12 polling site changes for the Joint General and Special Election scheduled for Saturday, May 3, 2003. These changes are due to voters' preference and accessibility issues.

FINANCIAL IMPACT

Funds for the election are provided under the Municipal Elections budget. This election is estimated to cost \$367,926.86.

COORDINATION

The proposed ordinance has been coordinated with the City Attorney's Office, Office of Budget and Management, as well as with the Bexar County Elections Administrator, Northside Independent School District and East Central School District.
