AN ORDINANCE **34267**

AUTHORIZING THE FLUORIDATION OF THE CITY PUBLIC WATER SUPPLY SYSTEM OF THE CITY OF SAN ANTONIO, PROVIDING FOR THE REGULATION OF SUCH FLUORIDATION, AND DIRECTING THAT SAID FLUORIDATION BE PLACED INTO OPERATION AS SOON AS FEASIBLE.

Whereas, the medical profession has determined that fluoridation of public water supplies is an effective and salutary aid in the care of teeth and prevention of decay and diseases thereof; and,

Whereas, the City Council of the City of San Antonio, Texas deems it in the interest of health and welfare of the citizens of the community that they be provided with fluoridation of the City's water supply, NOW, THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

1. That the Water Works Board of Trustees of the City of San Antonio, Texas is hereby authorized and instructed to proceed with the fluoridation of the public water supply system, after obtaining plans for the necessary equipment, installation, operation and procedures involved in such system by the State Department of Health.

2. That said fluoridation of the public water supply shall be placed into operation as soon as feasible.
