AN ORDINANCE

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND THE ACCEPTANCE OF FUNDS, UPON AWARD, FOR THE MAYOR'S PHYSICAL FITNESS COUNCIL GRANT PROGRAM FROM THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES IN AN AMOUNT UP TO \$100,000.00.

WHEREAS, the Texas Department of State Health Services (TDSHS) administers a grant program funded by the Mayor's Physical Fitness Council as part of the Governor's Advisory Council on Physical Fitness; and

WHEREAS, this initiative promotes the development of local fitness councils through the office of the Mayor; and

WHEREAS, local fitness councils have the ability to bring together key members of the community to identify solutions that are tailored to address local needs; and

WHEREAS, strategies that increase physical activity levels include community-wide campaigns to enhance access to and awareness of places for safe physical activity; and

WHEREAS, local fitness councils can also bring together organizations, agencies and businesses that share in the vision of a healthier, more physically active community, and leverage these resources into a larger, more visible community-wide effort; and

WHEREAS, TDSHS funding through this initiative will be awarded in two separate phases; and

WHEREAS, phase I funding will be for a period March 1, 2010 through August 31, 2010, and Phase II for September 1, 2010 through August 31, 2011; and

WHEREAS, the San Antonio Metropolitan Health District, on the behalf of the Mayor's Office, will request \$15,000.00 and \$85,000.00 for Phases I and II respectively, for a total grant request of \$100,000.00; and

WHEREAS, phase I activities will include the establishment of a Mayor's Physical Fitness Council, community needs assessment, and development of a social marketing campaign; and

WHEREAS, the social marketing campaign will focus on the creation of a web-based interactive social media platform to promote physical activities; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or his designee in collaboration with the Mayor's Office, is hereby authorized to submit a grant application and accept funds upon award for the Mayor's Physical Fitness Council Grant Program from the Texas Department of State Health Services (TDSHS) in an amount up to \$100,000.00. A copy of said application which is incorporated herein for all purposes is on file with the San Antonio Metropolitan Health District.


SECTION 2. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or his designee in collaboration with the Mayor's Office, is further authorized to execute any and all necessary documents to effectuate said grant application and acceptance of funds.


SECTION 3. Should funding be awarded Fund 26016000 entitled "Texas Department of State Health Service" is hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant and the sum of up to \$100,000.00 from the TDSHS will be appropriated in said fund. A formal final budget which will include a department specific fund, an Internal Order number, and General Ledger numbers will be submitted by the department upon award.

SECTION 4. This ordinance shall become effective immediately upon passage by eight (8) or more affirmative votes of the entire City Council; otherwise, said effective date shall be ten (10) days from the date of passage hereof.
