

AN ORDINANCE **45065**

AMENDING SECTION 2 OF ORDINANCE NO. 44,931  
PROVIDING FOR PRECINCT POLLING PLACES FOR  
THE REGULAR MUNICIPAL ELECTION TO BE HELD  
ON APRIL 1, 1975, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Section 2 of Ordinance No. 44,931 is hereby amended by changing the polling places for certain precincts as follows:

PRECINCT 108: From Hillcrest Elementary School,  
211 West Merida to Burbank High School, 1002 Edwards.

PRECINCT 226: From Neff Middle School, 800 Evers  
Road to Sunset Hills Elementary School, 519 Clearview.

PRECINCT 232: From Colonies House, 3600 Colony  
Drive to Colonial Hills Elementary School, 2627  
Kerrybrook.

PRECINCT 233: From Colonies North Elementary School,  
9915 Northampton to Colony House, 3600 Colony Drive.

PRECINCT 441: From Kingsborough Middle School, 9131  
Yett to Schulze Elementary School, 9131 Yett.

SECTION 2. Whereas, an emergency is apparent for the immediate preservation of order, good government and public safety which requires that this ordinance become effective at once; therefore, upon the passage of this ordinance by a vote of at least six members of the Council, it shall be effective from and after the date of its passage as provided for by Charter.
