



This charge includes moving 85 machines or more from the election center on Nueva Street to the various polling locations in the city, connecting the machines, and returning them to the election center at the termination of the election.


Enclosed is our cashier's check and we shall assume full responsibility in the event of any damage caused by us while the machines are in our possession.
