

AN ORDINANCE

35483

AMENDING THE REQUEST CONTAINED IN ORDINANCE NO. 35349, APRIL 20, 1967, TO REQUEST THAT THE URBAN RENEWAL AGENCY PROCEED WITH THE ACQUISITION OF CERTAIN PROPERTIES IN THE 200 BLOCK OF SOUTH ALAMO STREET UNLESS THE OWNERS THEREOF START ACTUAL CONSTRUCTION OR RECONSTRUCTION OF IMPROVEMENTS OF SAID PROPERTIES PRIOR TO JULY 1st, 1967, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Section 1 of Ordinance 35349, April 20, 1967, is hereby amended to provide as follows:

"Section 1. That the Urban Renewal Agency of the City of San Antonio is hereby requested to take the necessary steps to proceed with the acquisition of those properties located in the 200 block of South Alamo Street previously scheduled for rehabilitation by the owners thereof unless such owners commence actual bona fide construction or reconstruction of improvements on said properties prior to JULY 1st, 1967."

SECTION 2. An emergency is apparent for the immediate preservation of order, good government, and public safety which requires that this ordinance become effective at once; therefore, upon passage of this ordinance by a vote of at least six (6) members of the City Council, it shall be effective from and after the date of its passage as provided by the Charter of the City of San Antonio.
