CITIZENS TO BE HEARD

MR. CONRAD TRUSS

Mr. Conrad "Connie" Truss, Executive Secretary of the San Antonio Building and Construction Trades, distributed to each Council member a critique on the Sun Oil Contract which the City Public Service Board entered into May of 1974. They are of the opinion that the City Public Service Board rushed into this contract. He also stated that the Council should have more direct control on City Public Service Board.

At this point, Mrs. Dutmer made the following statement:

"Connie, you make some very, very good points, and at this point I'd like to bring up another matter that has occurred today. I know that you have conferred with different Council people concerning the appointing of Richard Solis to the Water Board. I also had reservations about it, but now it seems like the criteria that they want to put on the selection of the Water Board be that it be a southsider and a labor man. And, Connie, I'll tell you here publicly, I am not going to go for that kind of pressure. I think that we should be free to select the people that we want on these boards, the people who are going to do the job for the City. And, I just want to make it public right now that they can politic all they want to. They can pull all the strings they want to. They can hear all the pressures they want to, but I, for one, am going to do what is best for the City of San Antonio, political withstanding not taken into consideration." I also want to make this statement now, that, I, in no way blame you for fighting for your labor, this is your livelihood and we fought many a political battle together. We fought many a one on a different plane, and I, in no way would hold you responsible or anything else for fighting for your labor union. That is your livelihood.

MR. LOUIS CARDENAS

(At the request of Mr. Pyndus, the following discussion is included verbatim in the minutes).

MR. LOUIS CARDENAS: Mr. Steen and Members of the Council.

MAYOR PRO-TEM JOHN STEEN: Let me ask you to identify yourself, if you will, please.

MR. CARDENAS: I was just going to do that. My name is Louis Cardenas.

MAYOR PRO-TEM STEEN: All right, sir.

MR. CARDENAS: I'm a citizen here in San Antonio. I had been in contracting for the past seventeen years, and unfortunately, I've gotten messed up with a bunch of liars, if you'll pardon the expression, the Mexican-American Unity Council. The purpose today is to let you know what has been going on over there, what has transpired with certain contracts and certainly where the Mexican American Unity Council is concerned. Yesterday, I invited them to be here so that they could possibly defend themselves if they thought they could because I specifically called Mr. Patlan a liar.

MR. PHIL PYNDUS: May we have these remarks go into the record for Council investigation. Thank you.

MR. CARDENAS: I was hoping that they would show up because I specifically referred to Juan Patlan as a liar. Leo Ramos as a bigger liar and the poor old Gabriel Tafolla.

MR. STEEN: Mr. Cardenas, could I interrupt you just a second for Mr. Eureste.

MR. CARDENAS: Sure.

MR. BERNARDO EURESTE: I'd like to know what Mr. Pyndus mean by that statement that he made?

MR. PYNDUS: I'll tell you specifically, Councilman. There's some accusations about contracts to an organization that we fund. An organization that got over \$100,000 more because of Council action by certain members. I'm most interested to know whether or not these contracts are being handled accurately, according to public law and without any - these are strong accusations. If they have grounds, I think this Council should take some action if they have grounds and are proven, then it's our obligation to take some action with reference to these funds. That's why I'm asking for it to go in the record.

MR. EURESTE: You mean in the written record.

MR. PYNDUS: Yes, in the official record of this Council. So, it can be reviewed and followed up. I intend to follow them up.

MR. EURESTE: Good.

MR. CARDENAS: And I am also insinuating that one of the clerks or one of the inspectors working over there along with someone else and I'm not accusing, I said I'm insinuating that they're definitely getting kickbacks, and it is up to you to decide after you have heard me.

MR. STEEN: Mr. Cardenas, let me interrupt you one second. Who is back there as City Attorney, Mrs. Macon or Mr. Alex Briseno. She'll be down in a minute, Councilman.

MR. STEEN: I don't- Mr. Cardenas, what I'm worried about, I don't want you to get into any legal trouble because you are standing up there making some very personal accusations. I want to be sure.

MR. CARDENAS: I didn't say that I had accused anybody.

MR. EURESTE: You're accusing people of receiving kickbacks.

MR. STEEN: Here is Mr. Reeder, let's ask Mr. Reeder, he's one of our City Attorneys.

MR. CARDENAS: I said that I was implying that one of the two of the workers are getting kickbacks. Implying, not accusing. I have no proof. That would be determined by them.

MR. CRAWFORD REEDER: I just stood up because Mrs. Macon told me to answer any questions that might ordinarily be directed to her, and she wasn't here. I don't see a legal question here. This is a legislative meeting and a public meeting. They might sue him for liable, but I don't think they'll win.

MAYOR PRO-TEM STEEN: Thank you, Mr. Reeder. Mr. Cardenas, excuse me for interrupting you, you go right ahead.

MR. CARDENAS: I'd like to say with regard to what I have sounded like I'm actually here asking for your help. Very briefly, I've got most of my stuff written out here. I started my first job sometime in June of 1977 for a Mrs. Alvarado at 116 Del Valle. And that job was completed approximately the sixth of August of 1977. And some of the extras that were not on the contracts that are not on any of my four contracts that I was forced or made to put in the extras if I wanted my money. Work that was not on the contracts, and I have them here for your examination when I get through, for instance, and this is not too much, inclose a porch and put the new facings around the front windows. These are old windows that were there before I did my new work, and none of this was mentioned in the contract. And after I finally got the completion certificate signed, I got my check approximately 60 days after I finished the job. Now, you'll find this conglomeration of stalls consistently, somebody would have referred you to a title company, the title company referred you to Mr. Herschal Bernard. Mr. Bernard to Mr. Ortiz of Alamo Title, and then back to the organization. It's obvious they do not have a system. There is expertise, and they don't know what's going on half of the time. The minute you start a job, the paper work should commence and that won't mean a thing unless everybody's happy, unless the City Inspector is happy. But they don't, for some reason I don't know why.

Next, an incredible situation of July of 1977. I was the low bid for a Mrs. Mauricia L. Elizondo of 2518 Saunders. The complete work and the completion certificate was signed after we put a post and a new sill under the porch, which was not on the contract. It was on there to level it, but it could have been easily fixed with a brace. So, consequently, I still had to do that. Three weeks later, I asked about my check, and listen to this. Believe it or not, they told me they were sorry, but due to a mistake that they made, the Board at the Mexican-American Unity Council had not even approved this job. After I was a low bid and did the job, it had not been approved. However, they said not to worry that Mr. Patlan was going to Washington to get the money. A month or so later, I got my money when I said I was going to City Hall.

While I was completing this job, I started the job at 2021 San Luis Street for Mr. and Mrs. Adolfo Kara. After various delays, due to my not having sufficient money, and trying to get more money from the bank, I finished the job about two months later. Well, I needed more money, so the owner signed an extension to the First State Savings and Loan, so I could get more money. By the way, all these people so far are very old people, are widows, or what have you. These people here have been very nice and wonderful people. So, before that, I got out of there, the man put all of his furniture from the big house into one room, consequently we got through there, and he said that, "well your painter claimed that he would be willing to paint this room for \$30.00, why don't you give me the \$30.00 and the paint," which was wholesale for \$14.00 for two gallons which we have to guarantee everything for one solid year. So, I was ready to do that, naturally, to get my money. But here comes our dear Mexican-American Unity Council, and they said you're supposed to replace the window glasses and two or three aluminum screens in the back. I said that they are not in the contract. Well, I don't know what to tell you that is what they want. I said, look how much money you want total. They said \$110. I gave them a \$110 and got out of there fast. If you passed by there today, they're there but they haven't been installed. The aluminum screens have not been installed, and the glasses have not been installed. Naturally, those items were not on the contract. They told me the customer needed them, and it would cost me the \$110 if I did the work including the painting. I finally got my check minus the \$110. January 3, 1978, and as I just told you none of that work has been done.

During all of this time, I had also started the work at 2403 W. Durango and ladies and gentlemen, that is why I am here now. The owner of this home is Moses Gonzales and wife. Believe me, I've never known a man that wants everything for nothing because the Mexican-American Unity Council is backing him 100% and I'll show the statements in a minute. So, you be the judge. The owner has not signed a completion certificate to this day because he keeps wanting more and more things that are not on the contract. It's obvious what he is doing. He figures that as long as he doesn't sign, he doesn't have to pay, which is in a way, right. And the Mexican-American

Unity Council knows that if he doesn't sign, they don't have to pay me. It just goes around in nice little circle. He didn't have the money once before, I doubt it they have it now.

MAYOR PRO-TEM STEEN: Mr. Cardenas, are you nearing the end of your speech? You have very much more?

MR. CARDENAS: I want to show you the affidavit.

MAYOR PRO-TEM STEEN: All right sir, your time is just about up, really.

MR. CARDENAS: I didn't know I was here on time. Okay, let me get down to the - This is one of the first lists that I got of work that had to be done there. The circle here where they're not on the contract and if anybody wants to check the contract, I have them here. I want to know why the Mexican-American Unity Workers make these recommendations. There is a kickback they're not doing it out of health.

Last - on the 22nd of last month, I was here to complain and Mr. Juan Patlan caught me outside while you all took the break. He said, "Louis, please don't go and say anything about that to the Council." I said, "Look, I'm not here to attack anybody personally," I said, "I haven't got my money before Christmas and you haven't had the decency to give me the money to let my men have a decent Christmas. To make the story short, he said "I'm begging you for the third time," out there at the steps. To make the story still shorter, he said, "Let me call my attorney, Mr. Herchal Bernard" and he did it in front of me and he promised me the check the next day. I went the next day, and he wasn't anywhere around. They sent me to Leo Ramos. Leo Ramos said the work is terrible on the inside and on the outside. I went immediately to the City of San Antonio and I got my inspection and here is a copy of it, gentlemen, right here, and it says OK on final floor addition. Yesterday, they didn't send me this, The Mexican-American Unity Council signed by Gabriel Tafolla. Very briefly, "This letter will serve as official notice giving you ten days to have, your crew report to 2403 West Durango and start completing the work you started. If the job is not completed, we will have to take further action." And stuff like that. Now, watch this attachment here, this is not from the Mexican-American Unity Council but they sent it.

MR. FRANK WING: In the interest of time, if the gentlemen put all the information together and let Council see it because if there are any more citizens to be heard - we don't extend the same privilege to everyone.

MR. CARDENAS: I can close in one minute flat.

MAYOR PRO-TEM STEEN: What we're doing, Mr. Wing, Mr. Cardenas started, and we interrupted him so many times that we got lost in his time.

MR. CARDENAS: I'll close in one minute flat. The last list I received was not from them, but they sent it, and the owner still is asking for more though it's not on the contract. Why are they doing it? I say there's a kickback. Thank you, sir.

MAYOR PRO-TEM STEEN: Mr. Eureste.

MR. EURESTE: Well, I thought it was more serious than this, especially when you started talking about kickbacks, without qualification, and after hearing the story, I can tell that he's a contractor like we have many contractors that are working with this one particular program that is run by SADA. I am a member of the Housing Task Force for the City Council, Councilman Ortiz is the Chairman, and Councilman Alderete is also a member of that. And I can tell you that we get many cases like that where the client is dissatisfied with the job, and they get our committee all in embroiled in trying to figure who is right and wrong.

We have a case right now on that committee that has been pending for at least six months. It involves a contractor, there are City departments and sections and units that have given approval on certain aspects of the job. The client is dissatisfied; the contractor has said that he's done the best he can. Winston Martin and the people from SADA are involved in conducting an inquiry in trying to satisfy the client, and the Housing Task Force is caught in the middle trying to figure out who is right and who is wrong. I can tell you, I don't know where the word kickback comes from, but you know we have had situations over there where toilets have had to be replaced because they weren't satisfied with a certain brand. Where they're making a special arrangement right now on this particular house where the water heater was supposed to be removed to an outside storage, to an outside shed, it was left in there. Coming before our Committee the arrangements have been made so that water heater probably can be taken care of. This is way after and the check has not been released to the man. And the final approval on that job has not been countersigned by the customers, by the clients. And that job, I don't know what the total amount of dollars involved in these particular contracts that are cited here, but in this one that we're dealing with, you know we're talking about 7 or 8 thousand dollars of work. There was skirting that was done on the side with mortar and that mortar is cracking. Rudy Ortiz and I went out there to inspect all the complaints they had. They must have had 25 complaints on that one job. And this is very typical. You're going to find this situation when you're doing rehabing on older homes. You're going to find this. What is good work on skirting with you know, concrete or mortar on the side of a house, what is the best job. You know how much paint you scrape off a wooden house. This is a problem that has been debated back and forth between the client and the contractor and SADA and ourselves. The customer says we want more scraping done on that paint, it's already painted, but we wanted more scraping done. SADA says that's about as much as you can do for the amount of money that's involved. The contractor apparently feels satisfied that he did enough scraping or that his people did enough scraping. We're looking from the outside saying "Boy, that's a lot of money to pay for a paint job and not get a good scrape job on that surface". And I think, you can investigate it - you'll enjoy it because you'll never find a good solution to it. You'll never find a good solution to it. Because it's just a matter of contention. I think it's wrong though, I think he has every right, however, I guess he wants to do it. I don't think it's right to accuse in an open forum like this, people of kickbacking here and there. I think if you've got your check that hasn't come to you because there's not a satisfactory agreement, I think that's one thing, but to come in here and run accusations of kickbacks, I think that's pretty heavy and I don't think that's right. I think I would be willing to work with him, sir.

MR. CARDENAS: We're talking about over \$12,000, \$11,156 for the permit and the other lien that I'm filing tomorrow for all the extra work that I've done, and I'm also going to see Mr. Henry B. Gonzalez on this no matter what you take.

MR. EURESTE: Sir, we have a man that has a \$400,000 contract for about the time that he's been working with SADA who is about to lose his contract because we can't get a satisfactory agreement, and we're preferring right now to side with the client than to side with the contractor.

I mean you know, the point is to get a satisfactory resolution, I think you can get it.

MR. STEEN: Benny, thank you very much. Benny, I thought we were going to get through today without one of your speeches. But we didn't quite make it. At any rate, it was pretty good. Let me say this, as long as I'm sitting up here, hold up your hand and put it back down. I caught your name and I'm going to call on you. It will save you a lot of armwear at the end of the day. So, Mr. Cardenas, if you'll just wait a second, I want to call on Mrs. Dutmer, she had her hand up there first, and then Mr. Wing we'll get you.

MRS. HELEN DUTMER: Yes, I think the difference here and since you referred to Helen and investigations. Yes, Benny, I am going forward with investigations, because this man coming up here today, I didn't know was going to be here, contrary to what you may have in your own mind. However, it is only one of the small symptoms of a bigger cancer that is in MAUC, and it will surface, it will come out and you're knit picking because what you're doing on the San Antonio Housing Authority is dealing with an agency of the City by an agency of the City. This is an agency using public dollars on a contract to the City, which makes it an entirely different ball game of the whole situation.

Now, the fact that this man hasn't got his money as yet, does come from one of the complaints that I have come across my desk, and it just so happened that I took a contract on a builder out there. We checked that contract out. Everything that was on the contract was done. The things that allegedly were not done did not appear on the contract. When it was discussed, there were a thousand reasons why this man has not gotten his check particularly before Christmas. Because he couldn't pay his workers. I remember having a taxicab driver here who everybody was bleeding all over the floor for him because he wasn't going to have any Christmas. So, this man here had a whole crew who didn't have any Christmas simply because the check was held up on a small technicality that the people didn't like the work that was done. And I mean you might bring me a cadillac and because I don't like the color of the thing, I'm not going to sign the papers. That's immaterial. I just don't see your line of reasoning - I do see your line of reasoning, let's put it that way. But your reasoning is completely off base as far as I'm concerned.

MAYOR PRO TEM STEEN: Mr. Wing.

MR. FRANK WING: I yield to Mr. Eureste.

MR. EURESTE: Yes sir, I think my line is pretty solid. I think on this particular case I have more experience with it than Councilwoman Dutmer. Much more experience, much more experience. We had sat on this Committee and dealt with this very problem, and I can tell you that we could have brought another contractor to look at this particular job that we were looking at and that contractor would have come up with a different story. The more people you bring on to a job, you're going to have different interpretations and different views. That's all there is to it. The Unity Council operates a program very similar to SADA. As a matter of fact, there are monies that go to the San Antonio Development Agency approved by the Housing Task Force as we approved other things in there. Funds that go to the Unity Council, and this is not something that was initiated by the Council or this committee. It's something that has been initiated in prior years. The programs are similar, the difference is the dollar match. The Unity Council uses more private sector dollars to mix with public sector dollars, than SADA does. SADA is doing it mostly with public sector dollars. They award contracts; they have contractors they work with. The contractors do the job and then pending approval from various agencies of the City, the people that are involved,

the recipients of the service, the providers of the service, the intermediaries, etc., the deal is closed out, and if you've got problems somewhere in between this thing can be held up. And I think this is normal. But, I think it's wrong to look at this problem, you know, as a problem that is unique to the Mexican-American Unity Council, when you're in housing and rehabing you're going to have these kind of problems.

MAYOR PRO-TEM STEEN: Thank you. I think we're getting a little repetitious. If we're going to make various speeches, let's change them a little bit as we go along. Mrs. Dutmer is next. Then Mr. Pyndus.

MRS. DUTMER: I want to make one more statement, and that this is not the first time the Mexican-American Unity Council has been defended by certain members of this Council. The fact is there is an investigation that is going to be implemented and anything you do is not withstanding it's not going to stop that investigation one way or the other, not withstanding myself or any member of this Council or anything else. The investigation is going forward.

MR. EURESTE: I would like a clarification on that, sir. Is this an investigation on this particular complaint by a Council member or is this going to be an inquiry that's going to be conducted by departments that have the responsibilities to carry out such inquiries.

MAYOR PRO-TEM STEEN: Benny, I hate to do this to you because you're Mr. Robert's Rules of Order on this City Council, but you're out of order.

MR. EURESTE: Point of clarification can be raised at any time.

MAYOR PRO TEM STEEN: Not without the chairman's recognizing you.

MR. EURESTE: Yes, sir, it has precedence over any other hand that is being held up at that point.

MRS. DUTMER: I'll be glad to clarify the point. It's common knowledge that I have asked for a federal investigation of MAUC because of some of the affidavits and other sworn testimonies that I have by people who have dealt with the Mexican-American Unity Council, and the investigation is going forward.

MAYOR PRO-TEM STEEN: I think Mr. Pyndus is next and then Joe, you're next.

MR. JOE ALDERETE: I just have a point of information. There is a representative here from MAUC who could probably defend the organization.

MR. PYNDUS: Well, I think from the time that's involved - I would like to take an approach to it. First of all, we must encourage people to come before the Council and we must not shut them off. And we must not get into an inter-Council spat, so that we lose credibility. Now, MAUC received funds to go into the Housing Business there was some opposition to it because they had to have another staff - they had to have administrative costs that if SADA had handled it this cost would not be involved.

Now, Mr. Cardenas has come before the Council and mentioned the fact that the staff doesn't know what they're doing. And that he had words with some of the MAUC staff and I think that this bears with the Housing Committee a look - see - to see how they process applications - I think it's the Council responsibility to see that it's running smoothly. And, so, in that respect it should go to the full Council, to see if they're running a credible program.

And, then, secondly the very strong accusation of alleged kickbacks is a criminal offense and if names are mentioned and if these alleged kickbacks can be proven, then the Council should do something about it.

So, my request that it go into the record so that we would follow up later and get some credibility and some proof and then we could move with it. And this is what I would recommend to the Council that we give it to the Housing Committee and have them investigate the fact and bring it back to full Council.

MAYOR PRO-TEM STEEN: Joe, you were next. I don't know if you were finished or not.

MR. ALDERETE: No, it was just a point of information. There is a representative from the Mexican-American Unity Council here that could probably speak to some of the points raised by Mr. Cardenas, and that was my only point.

MAYOR PRO-TEM STEEN: Benny, you were next.

MR. EURESTE: Well, the strong statement was made about kickback. There was never anything said about amount. I heard one amount, \$110.00, but that \$110.00 involved apparently the purchasing of some material. And the material apparently was purchased. Now, I don't know what the agreement called for as to who was going to place that material on the house, or in the room, or whatever. Now, how much money are we talking about kickback. You talk about kickbacks, I want to know how much money are you talking about when you say kickbacks. Give me a total.

MR. CARDENAS: I don't have the least idea. That's become a City question. The man that I invited here has not shown up yet. I want him to answer the question.

MR. EURESTE: Mr. Cardenas, you come in here and accuse somebody of receiving kickback, I think the least you can do without telling us who gave what to whom. How much money are you talking about? Give me a total.

MR. CARDENAS: How in the world can I possibly know if this goes on consistently, and they keep backing the owner. The man is standing right here, I invited him here, I invited him here, not you, I invited him here.

(At this point Mayor Cockrell returned to the meeting and presided.)

MR. EURESTE: You make a lot of very strong statements.

MR. CARDENAS: You want me to say \$100,000, I'll say it.

MR. EURESTE: Well, that's for the record. You just said it.

MR. CARDENAS: I want to know why this man wrote this letter to me, recommending that these things that are not in the contract be put in by me. This is Mr. Tafolla.

MR. GABRIEL TAFOLLA: My name is Gabriel Tafolla, Director of the Neighborhood Housing Services of the Mexican-American Unity Council, and I have heard Mr. Cardenas' accusations, and I think they are completely unfounded and I do not want to get into a lengthy discussion. I do want to make a few statements. First of all, our checks for this amount of money, were made on December 2, 1977 to a Mr. Cardenas. We have released our checks to the title company. The checks are not in our office, the title company, Alamo Title Company has the checks. They cannot release them until the people sign. The bank cannot release the money. Our money cannot be released. No one's money can be released until the owner signs that they are satisfied. Now, what I am prepared to do and have always been prepared to do is to sit down with Mr. Cardenas and the homeowners and try to reach some compromise. We are merely in the middle.

The contract is between Mr. Cardenas and the homeowners. We are trying to get technical assistance. We have private money involved. Our interest is great. We have given a part of our monies approximately 1/3 of the \$11,000 involved, and we're interested in paying this money. And our record, we want the record to show that our interest is making as many loans as possible. We're under pressure to put loans out. We wish we could settle this tomorrow. We wish we could have done it 30 days ago, but Mr. Cardenas and the homeowner have not been able to get together, and I'm here pleading with Mr. Cardenas to come into our office and set a meeting with the homeowner and possibly if we could have some assistance from the Housing Committee. So, that we can pay Mr. Cardenas, I want to pay Mr. Cardenas. That is all.

MAYOR COCKRELL: Yes, Mrs. Dutmer.

MRS. DUTMER: Madam Mayor, these people have had months to set up a meeting of this sort and haven't even attempted to. Now, all of a sudden everything is moonlight and roses.

MAYOR COCKRELL: Well at any rate, I know we can't settle it right here, because the Council is not the authority to be the one to settle this. I do think that the suggestion that was made that there be a meeting between you and the homeowner to see if it can be adjudicated is probably the best thing at this point.

MR. CARDENAS: Your honor, he didn't answer my question.

MAYOR COCKRELL: Well, sir...

MR. CARDENAS: Just like Mr. Eureste over here. I was talking about... extras that the owner wants, and he comes out with not being satisfied. They twist the things around. He didn't mention - he didn't answer my question.

MAYOR COCKRELL: Mr. Cardenas, you understand that this Council was not a party to the contract, and we have not been involved in any of the inspections. And really there is not a direct jurisdiction over the settlement of this issue. You have used this as a forum, an opportunity to present your concerns and certainly we have been happy to hear them. And I would just recommend to you that you go ahead with the next step which I think is to go to that meeting. Mr. Eureste.

MR. EURESTE: While you were out, Madam Mayor, I don't know if you heard the discussion.

MAYOR COCKRELL: I heard some of it, yes.

MR. EURESTE: Do you know what I had to say?

MAYOR COCKRELL: I didn't hear it all.

MR. EURESTE: Well, I don't want to repeat it for you.

MR. PYNDUS: Don't repeat it.

MR. EURESTE: I won't repeat it. I'll just let the matter drop.

MAYOR COCKRELL: I had received a long distance call. Is that fine? Thank you, Mr. Cardenas.

MR. CARDENAS: The only reason I was here, Mrs. Cockrell, is because the project is funded by you all. And I did put my point over to you, and it wasn't answered and I thank you all very much.

MAYOR COCKRELL: Fine, thank you. Mr. Pyndus.

MR. PYNDUS: Mayor Cockrell, I'm not particularly happy with the way we're handling this, and I think that it bears looking into without wild accusations. But I do think that some of the complaints that have been filed with us publicly, I think that we should look at them rather than place him back to the people he's complaining against. This involves a lot of dollars in the housing program, and I know that we have a lot of red tape, a lot of knit picking, but there are several things that were mentioned here that I think bear looking into, and I feel...

MAYOR COCKRELL: All right, let me make this suggestion then. I think there is a matter of sort of due process in the settlement of claims. And I think one step if I have heard correctly, that there has not yet been a meeting formally between the contractor and the homeowner and the Housing Committee. That this has not yet taken place, and this would sort of be the next step in the due process. And that I think the Council would certainly want to get a report, and if this is not successful in resolving the issue, in getting it cleared up, then I think the Council can then review if there's any further role for the Council or its staff to play. Yes, Mr. Eureste.

MR. EURESTE: Madam Mayor, I don't know how long this gentleman has been in the business, but I think that any contractor who knows the business understands that there are this type of delays that you incur. I think that's what has happened here, I mean the check is with the title company. You have to have a sign off from the clients and from the contractor. SADA has the same arrangement, and if Council wants to start hearing the complaints we get on the Housing Task Force which are very similar to this, and we haven't turned around and said that SADA is crooked and that SADA is dirty. You know these are very normal things that happen in this type of business. Very normal, and I don't think it's rights for us to launch investigations on matters that are as complicated as this, and I think part of the answer was provided here. The check is with the title company.

MAYOR COCKRELL: All right, Mrs. Dutmer.

MRS. DUTMER: I think we've gotten to the bottom of the matter. My motivation for this - asking for investigation of MAUC is not because it's the Mexican-American Unity Council, but because I feel that public dollars that were alloted to an agency for the help of people that need help, are not going to the people who need the help. And any time that we do give the public dollars to an agency, I want to see those dollars get down to the people that need the help. I know - I think we're taking the wrong angle in again having Mr. Cardenas go back to the people he has the grievance with. I have no quarrel with it, however, if he has someone there that will arbitrate this thing and get it off the ground. As I said it's been going on for months and they never made any attempt as yet to alleviate the man's condition. And I hope and I'm very happy, I don't care what method they take as long as they get it off the ground and do some acting. This isn't the only complaint that I have. And they all involve the same agency and that is where my concern lies, not in any other direction.

MAYOR COCKRELL: All right, Mr. Eureste.

MR. EURESTE: I don't like those kind of statements that are made. I don't like to sit by here and see this agency or any other agency accused in like manner. Funds that are awarded by this City which are public dollars which should go to agencies, which are supposed to get down to the people. In many cases the type of dollars that we award as a City aren't intended to get down to the people. We don't provide monies to agencies to do cash handouts. Most of the funds are for salaries of people that work in those agencies. Any social service agency that we're

supporting, the free clinics, etc., etc; the Family Services Association of San Antonio, the Boys Club is to pay for administrative cost and other amenities. There's not one dollar, not one red cent that goes to the recipient of service from that agency. We have different funds for the Unity Council. We have revenue sharing funds. We also have funds to SADA that are used for loans and to package loans for rehabing houses, and I just don't like those kind of accusations.

MAYOR COCKRELL: Alright, I think Mr. Steen had his hand up.

MR. STEEN: I think we're turning into Council to be heard, and I'd like to hear from the next citizen. \* \* \* \*

Later in the meeting, Councilman Eureste asked to be recognized and the discussion continued:

MAYOR COCKRELL: Those are all the persons registered to be heard, and I think now that Councilman Eureste asked for recognition.

MR. EURESTE: I wanted just to bring back a part of the discussion that we had a little while ago with Mr. Cardenas, I think, that was concerned with some difficulties that he was having with the Mexican-American Unity Council and the release of a check for contract work that he had done. These are some pictures on some of that work. What you see here is foundation work right here. There's a boulder and on top of it is a piece of board for spacing and on top of that is a girder for the house. One of the clients, the owner of this house went underneath and that's what he found. An owner will not release papers on a contract or for this type of work. This is paint on a window, and if you'll notice, you know, when you're painting windows from the outside you have to, you have to lower your top window to the bottom and raise your bottom window so that you can paint that little strip that's always hidden. This part was raised and this is what was discovered, a part that was not painted. And, I don't know exactly what this shows, but I have a couple of more on this.

MAYOR COCKRELL: Some of them have notes on the back, too.

MR. EURESTE: These are the addresses. This shows a girder that is not connected and what you have there is a weak hollow flooring. The girder as it comes in from the flooring, that rests on top, there's a spacing in between. That means that the girders have not been connected to one another. I'm not in the construction business, but I do a little work like this for extra money on the side, and this is how I know about these things. The other is, this is mold, mildew that shows on the false wall next to a bathtub. The plumbing is leaking, that's basically what happens, and the moisture gets back there and then through condensation or whatever it goes to the other side of the wall you've got mildew coming on the other side of the wall. And this one here will show the sash, the window sash work that was done, it is not even.

Now, I'm not going to say who's at fault here or what but these are some of the problems that you run into. The reason I said that you, on the committee that Rudy, myself and Joe sit on the Housing Task Force. We get complaints like this and it's very difficult, you know, for us to say this person is at fault, or it's over here. It's very difficult and we have to do, we have to take time and look into the matter. I think what clouded the whole situation was that there were allegations of kickbacks which I just do not like. I think that if we had dealt with the problems, I think we could resolve them and then we would be willing to work on them.

Let me give you some examples of three cases that had come before our Committee. The pump plumbing - this is on one construction on one rehab., dissatisfaction with installation of new commode which apparently does not drain properly and water is coming out of the base of the commodes. Number Two: Complaint of an odor emanating from the shower water. Three: Faucets and fixtures of inferior quality. Four Aluminum screen doors. They asked for wooden doors. Five: Front door unacceptable because of condition-

there's a crack on that front door. Six: Questions regarding sheetwork installation. Seven: Light fixtures on porch do not match. One was a brass plated, the other had black paint on it. Eleven: Failure of the subcontractor to clean up each job that he finished. Thirteen: The skirting on this particular house was very thin, apparently, he had a poor mixture and it was cracking. Now, there are some people who say that the skirting will crack. There are others that say that if it is a good job, it will not crack. All right, here is another case. There is no toe space under the kitchen cabinet. Well, when SADA went back and checked it, they said you didn't have toe space when we started, and you don't have toe space when you finish. You know there was nothing in the contract that said we were going to give you toe space. Doors do not close properly and here the contractors and SADA will tell you if you've got a shifting house you're going to have problems with that. Anybody that has cedar post foundation is going to have a shifting house with doors and windows that stick. The kitchen window needs paint; gutter in the front not complete, and one last one this one has 16 complaints. Caulk and renail quarter round the porch. This is what SADA is saying.

Here's another one - it appears that the screws used to secure the hinges on the exterior door are not long enough, and will eventually pull out the door frame. We are requesting the contractor to use longer screws in its installation, and it goes on and on. Here's three complaints for three houses, and you've got a total of 34 complaints, and anyone of those could hold up the countersigning that goes on between the contractor and the owner of that house. Those are the problems that we deal with in our committee and Rudy and Joe are there to testify that these are the types of cases that we hear. And this is not to accuse SADA, though, of being crooked, of being corrupt or having a cancer in them. These are normal problems that you have when you get into this kind of business.

MAYOR COCKRELL: And you all would be willing to help sit down in that meeting and try to adjudicate it.

MR. EURESTE: Sure.

MRS. DUTMER: This is fine. I agree to it, Mayor, but what I see here is a group of pictures of an underside of a house with no addresses, no identification of the house whatsoever. Other than the underside of the house and in one instance there it's not even the same house. It's the two other contracts that the man held, and both of those were paid off. So, I think that's beside the point. This other home here - the one that's in question now was started some months ago. There's been a couple of months in between there where it wasn't paid up. Now, I know that I went there a few weeks ago with the builder and none of these problems were pointed out. The people didn't even complain about these problems that they have here that they are complaining about now. And, it's just a very ticklish situation and as I said before, and I'll restate it - it's fine, the Housing Authority and the rest of them want to get together so long as you start doing something and look into these problems. This is what I asked for in the beginning and no one made a move. So, I went further.

MR. ORTIZ: Madam Mayor, we have had a number of cases, and we haven't heard all of them, but we have had a number of cases of homeowners that have had their houses remodeled or rehabilitated who have come with a number of complaints, and some of them are rather serious in that the amounts that are charged for remodeling and rehabilitating are very hefty sums of money, and, of course, it affects the family financially and it affects the quality of their living in those houses.

It might be that this Housing Task Force might have to consider going into a series of hearing and accept the different complaints

that are coming in from the different homeowners and then come back to this Council with a full fledged report as to the extent of the problem. And perhaps it might have to come down with the Housing Committee recommending to this Council that we go ahead and have the licensing of contractors, and sub-contractors and homebuilders and rehabilitators and remodelors and what have you - if the problem is that big and serious. As Chairman of the Task Force, I haven't perhaps pursued this as strongly as I would want to, but, perhaps, if the problem seems to be that serious I'm sure that the rest of the committee members would have no problem with opening up some full fledged hearing on this matter.

MAYOR COCKRELL: Mr. Ortiz, I was going to say that part of the problem may get down to when the contracts are written. Perhaps, there are things that are in the mind of the homeowner assuming that they will be done as a part of this whole package and yet they are not put into the contract and the contractor then is not going to do anything but what is actually written down, and there may need to be some help - more help given in consultation with homeowners entering into these contracts to be sure to get everything written down in the contract that they really feel is supposed to be included.

MR. ORTIZ: Right, and if I may respond to that. We've been working with the San Antonio Development Agency, their staff and other interested people that have come up to our Committee, and this is one of the approaches that we have taken. That there should be a lot more clarification and for instance when the inspector is out there to go and inspect the job that there should be a countersignature so that we can be sure that the owner, the homeowner, will be there whenever the inspector goes to check whatever foundation, electrical whatever kind of work is being done. I think it would help cut down on some of the complaints and some of the misunderstandings. However, at anytime that this Council feels that the problem is great enough - I would hate for this Committee to get bogged down with a lot of individual cases, and we went through one of these cases and it was long and drawn out and I just dislike tying down the committee to individual little cases like this. Although, I can sympathize with the people. But, if the Council feels that this is of a serious enough nature and wants to direct the Housing Committee to go into a series of investigative hearings or whatever you would like to call them - I would be glad to do that for the Council, and I'm sure that the rest of the members will also, and all I'm saying is that we are at the disposal of this Council whatever your pleasure is.

MAYOR COCKRELL: Thank you. Mr. Alderete.

MR. ALDERETE: I just have one point that I'd like to emphasize is that this home received our inspection - our City inspection, and I'd like to know how in the world a block of cement and a 2 X 6 got passed our inspectors, and I would like Mr. Vann, George Vann or whoever and the inspector that certified this to come before us and really explain this. Madam Mayor, this is not just going on in this situation it's going on in a lot of other situations. I'm not trying to pick on a department, but the fact that it needs to be either strengthen - somewhere there's a fault there, and it needs to be reviewed and carefully examined and something done - some appropriate action taken so that the consumer is no longer ripped off. That's my only point.

MAYOR COCKRELL: Are these pictures that Mr. Eureste, perhaps, make available to the City staff, Mr. Briseno, and ask that we follow through with getting a specified report on the inspection that was taking place on this property.

MRS. DUTMER: I want to say thank you, Rudy, for being so level-headed about this. In the beginning all I did was ask this City to look into these infractions, and I got a memo back from the Manager saying that the City does not have the jurisdiction to look into an agency that we give money to. So, therefore, I was forced to take every avenue of redress that I had until I got to the top echelon. Had this been done in the beginning, but I don't know that the San Antonio Housing Authority or the Housing Committee would have the authority to go into a private agency that we contract with. I don't know what the jurisdiction is here, but I do thank you for being so reasonable and level headed about it.

CAMINO REAL HEALTH SERVICE SYSTEM

DR. JOSE SAN MARTIN, III

Dr. Jose San Martin, III, President of the Camino Real Health Service System, explained to the Council the function and duties of this system which became an entity in August of 1976. He stated that their Board of Directors consists of 30 members and explained their health system development plan.

At the request of Mrs. Dutmer, Dr. San Martin explained to the Council the topic of flouridation and its part of their health plan.

A discussion then took place on flouridation and its association as claimed by some groups with it being a cause of cancer.

DR. WILLIAM THORNTON

Dr. William Thornton stated that although flouridation is part of their health plan, there are many other areas that they are involved with. He also stated that every group involved in health care is in support of the use of flouride. He also explained the amount which is planned to be used and the purpose for its use.

MR. OSCAR ROBLEDO

Mr. Oscar Robledo, representing El Centro Inc., asked that his organization be allowed to paint murals in the inner City district. He stated that their organization is a minority enterprise, and this project could provide employment for many youths. They plan to submit a budget and a plan to Council at next week's Council meeting.

A discussion then took place on possible funding sources including CETA monies, Community Development funds, and revenue sharing funds.

Mayor Cockrell stated that this is a very interesting project and asked the staff to comment.

Mr. Alex Briseno, Assistant to the City Manager, stated that Mr. Skip Noe of the City Manager's Office works with the Fine Arts Commission and is familiar with similar projects.

Mr. Skip Noe stated that the Fine Arts Commission has expressed an interest on this type of project and he further stated that the National Endowment of the Arts does fund these types of projects. He has spoken to the Arts Council about this matter and will be glad to speak with the Fine Arts Commission.

Mr. Rudy Ortiz asked that a report be prepared for Council.

Mayor Cockrell asked that the Fine Arts Commission can be asked to identify the possible sources of funding and asked for a progress report in 30 days.

MR. THOMAS HILL

Mr. Thomas Hill, Principal of Guerra Elementary School in the Edgewood Independent School District, stated that their community is desirous of having the area across the school be made into a park. He then detailed the work done by the community in cleaning up the vacant lot. He stated that they have met and discussed this matter with the School District, and the School District has already approved the release of this land to the City so that it can be used as a mini-park

Mr. Alderete stated that he is very familiar with this area and emphasized the need for a park. He further stated that the size of the land is not that large and, therefore, the Operation and Maintenance cost to the City would not be very much.

Mayor Cockrell stated that this is a very worthwhile proposal and then asked that the Staff give the Council a report on this matter with special emphasis on the funding and a plan for the development of this park within two weeks.
