

AN ORDINANCE **42089**

DECLARING THE CANVASS AND RESULTS OF THE MUNICIPAL
RUNOFF ELECTION HELD ON THE 17TH DAY OF APRIL, 1973.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

1. The City Council having convened on this 18th day of April, 1973, to canvass the returns of the runoff municipal election held on the 17th day of April, 1973, to determine the members of the Council, Places Nos. 3,5,6,7,9, of the City of San Antonio under its Charter for the ensuing term of office of two years.

2. The City Council having met to canvass the returns and to declare the results of said election in the manner provided by law, and after considering, determining and canvassing all matters of fact appertaining, we, the City Council of the City of San Antonio, do hereby find and declare the results of the said election to be tabulated as follows:

3. The names of the candidates were submitted and the election was held and conducted and the returns thereof were made, all as required by the City Charter, the laws of the State of Texas and the proclamation of the Mayor, and at said runoff election there were cast respectively for each of said candidates of the aggregate number of votes shown above.

4. The City Council having canvassed said returns and having found the same in all things correct, the canvass was thereupon adopted by a majority vote of the members of the Council of the City of San Antonio; and it is declared that as the result of said runoff election, the elected officers of the City of San Antonio, being Councilmen Places Nos. 3, 5, 6, 7, and 9 for the two years commencing on the 1st day of May, 1973, are as follows:

- Member of Council, Place 5 Glenn Lacy
- Member of Council, Place 6 Clifford Morton
- Member of Council, Place 7 Alfred Beckmann
- Member of Council, Place 9 Leo Mendoza
