I, Dr. W. A. King, City Health Officer of the City of San Antonio, Bexar County, Texas, do hereby certify that on the 3rd day of Dec, 1917, in accordance with the authority vested in me by the Commissioners of the City of San Antonio, by virtue of an ordinance passed and approved on the 11th day of June, 1917, I caused to be improved by removing therefrom all weeds and brush, creating or causing a nuisance thereon detrimental to public health, the following described lots or parcels of real estate situated within the corporate limits of said City of San Antonio in Bexar County, Texas, to-wit:-

Lot 48 E.O. 3101 N. Side Nebraska

That the actual cost and expense of said improvements incurred by the City of San Antonio on behalf of Ira Armstrong the owners of said property, amounted to the sum of Five & ²⁵/₁₀₀ Dollars, which amount was, on the 3rd day of Dec 1917, charged to said owner and is now due and owing to said City of San Antonio, and no part thereof has been paid.

That said cost and expense of said work and improvements, amounting to Five & ²⁵/₁₀₀ Dollars, as aforesaid, together with ten per cent interest thereon from the 3rd day of Dec 1917, is a privileged lien upon said above described property, second only to tax liens and liens for street improvements, by virtue of the provisions of Chapter 184 page 405, of the Acts of the Regular Session of the Thirty-fifth Legislature, as carried into effect on said City of San Antonio by an ordinance passed and approved by the Commissioners of said City on the 11th day of June, 1917.
