AN ORDINANCE **35791**

AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE URBAN RENEWAL AGENCY OF THE CITY OF SAN ANTONIO FOR THE PROVIDING BY THE CITY THROUGH ITS PARKS AND RECREATION DEPARTMENT OF LANDSCAPING SERVICES IN CONNECTION WITH THE BEAUTIFICATION AND LANDSCAPING OF DURANGO STREET WITHIN URBAN RENEWAL AGENCY'S PROJECT, TEX. R-83; AND AUTHORIZING THE CITY MANAGER TO ESTABLISH ADMINISTRATIVE PROCEDURES FOR THE COORDINATION OF SAID PROJECT.

WHEREAS, the City has staff available which are expert in the field of landscaping, lighting, etc. in its Department of Parks and Recreation; and

WHEREAS, the Urban Renewal Agency is in need of services of such staff in order to complete the landscaping and beautification of Durango Street within its project area; and

WHEREAS, the Urban Renewal Agency and the City have agreed upon administrative procedures for the purpose of carrying out the services necessary; now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. The City Manager is hereby authorized to execute an agreement with the Urban Renewal Agency of the City of San Antonio for the providing by City of competent staff to assist Agency in the beautification and landscaping of that portion of Durango Street from South Alamo to the east boundary of its Civic Center Project, Tex. R-83.

Section 2. The agreement authorized in paragraph 1. is attached hereto and made a part hereof.

Section 3. The City shall receive reimbursement for the services rendered in an amount not to exceed \$6,200.00.

Section 4. Payment of the sum set forth in paragraph 3. above to the City shall be pursuant to administrative procedures as determined by the City Manager and the Executive Director of the Urban Renewal Agency.

A RESOLUTION

AUTHORIZING THE AGENCY'S EXECUTIVE DIRECTOR TO EXECUTE AN AGREEMENT WITH THE CITY OF SAN ANTONIO FOR THE PROVIDING OF LANDSCAPING SERVICES IN CONNECTION WITH THE BEAUTIFICATION OF A PORTION OF DURANGO STREET; AUTHORIZING PAYMENT OF AN AMOUNT NOT TO EXCEED \$6,200.00 PURSUANT TO SAID AGREEMENT; SUBJECT TO CONCURRENCE BY THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.

WHEREAS, the City of San Antonio, acting by and through its Department of Parks and Recreation has agreed to provide consulting landscaping services to the Agency for the purpose of the beautification of that portion of Durango Street from South Alamo east to the project boundary of Project Tex. R-83; and

WHEREAS, the Agency and the City have agreed upon the terms of a contract for such services; now, therefore


BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE URBAN RENEWAL AGENCY:

1. The Agency's Executive Director is hereby authorized to execute an agreement with the City of San Antonio providing services to the Agency in the landscaping, planting and landscape design of that portion of Durango Street from South Alamo Street to the east project boundary of Project Tex. R-83 in an amount not to exceed \$6,200.00.
2. The agreement is attached hereto and made a part hereof.
3. The actions taken herein is subject to approval by the Department of Housing and Urban Development.

AGREEMENT

This is an agreement between the URBAN RENEWAL AGENCY OF THE CITY OF SAN ANTONIO, hereinafter called "AGENCY", and the CITY OF SAN ANTONIO, acting by and through its Parks and Recreation Department, hereinafter called "CITY", in words and figures, as follows, to-wit:

1. Purpose. AGENCY has undertaken the construction of Durango Street within the boundaries of its Project, Tex. R-83 within the City of San Antonio. That portion of Durango Street extending from South Alamo Street east to the Project Tex. R-83 boundary is completed and ready for landscaping and beautification. CITY'S Parks and Recreation Department has staff available to provide services in the layout, planting and provision of shrubs, ground cover, trees, etc. according to plans prepared by said Department and approved by AGENCY. AGENCY desires to avail itself of these services.


2. Consideration. AGENCY shall pay CITY an amount not to exceed \$6,200.00 for all the services rendered by CITY in connection with this agreement.

3. Term of Agreement. Term of this agreement shall commence on the 28th day of September, 1967 and shall terminate when the planting of Durango Street is completed.

4. Administrative Procedures. AGENCY and CITY agree to establish administrative procedures for the coordination and use of AGENCY and CITY staff in expediting the project. In addition, administrative procedures shall be established before disbursement by AGENCY according to regulations and policies established by the Department of Housing and Urban Development of the funds authorized to be paid CITY herein.


