AN ORDINANCE **92782**

AMENDING ORDINANCE NO. 92256, PASSED AND APPROVED ON AUGUST 31, 2000 ADOPTING POLLING SITES FOR THE NOVEMBER 7, 2000, SPECIAL ELECTION, BY CHANGING THE POLLING SITE FROM 2920 E. SOUTHCROSS (ALBERTSON'S) TO THE NEW LOCATION AT LUTHERAN CHURCH OF GOOD SHEPHERD, LOCATED AT 1630 GOLIAD ROAD.

WHEREAS, Ordinance No. 92256, passed and approved on August 31, 2000, adopted polling sites for the Special and Joint Election being conducted on November 7, 2000, by the Bexar County Elections Office; and

WHEREAS, a polling site change is now necessary to be made because the Albertson's Store located at 2920 E. Southcross denied the County's request to use its facility on election day as a polling site; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 92256, passed and approved on August 31, 2000, is hereby amended to reflect the change to polling sites approved therein to change the polling site location from Albertson's Store at 2920 E. Southcross to the new location of Lutheran Church of Good Shepherd located at 1630 Goliad. A copy of this polling site change is attached hereto as Attachment I.

SECTION 2. This ordinance shall be effective on and after the tenth day after passage hereof.

FINANCIAL IMPACT


Funds for the election are included in the Election budget.


