AN ORDINANCE **5 679 3**

DECLARING THE RESULTS OF THE
CANVASS OF THE MUNICIPAL ELECTION
HELD THE 2ND DAY OF APRIL, 1983, IN
THE CITY OF SAN ANTONIO, AND
ORDERING A RUN-OFF ELECTION TO BE
HELD THE 16TH DAY OF APRIL, 1983.

WHEREAS, the regular municipal election was held on the 2nd day of April 1983, to determine the Mayor and Council Members of the City of San Antonio for the ensuing term of office of two years; and

WHEREAS, the names of the candidates were submitted, the election was held and conducted and the returns thereof were made, all as required by the City Charter, the laws of the State of Texas, the proclamation of the Mayor and the law for such cases made and decided; and

WHEREAS, the City Council met on April 4, 1983, in the Council Chamber at City Hall to canvass the returns of the said election; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council having convened April 4, 1983, to canvass the returns of the regular City election held April 2, 1983, after canvassing the returns of said election, the City Council does hereby find and declare the result of the election to be as follows:

SECTION 2. It is further declared that as a result of said election, the following persons were elected Council Members for two-year term commencing May 1, 1983:

Ed Harrington, Member of Council, Place No. 8
Van Henry Archer, Jr., Member of Council, Place No. 9
James C. Hasslocher, Member of Council, Place No. 10
Henry G. Cisneros, Member of Council, Place No. 11 (Mayor)

and each of them was elected by receiving a majority of all the votes cast for the office for which each was a candidate cast by the qualified voters of the City of San Antonio voting at said election, and they and each of them are hereby declared to be the lawful and duly elected Council Members of the City for the places specified.

SECTION 3. It is further declared that as a result of said election, no candidate for Place No. 5 received a majority of all the votes for the office for which he was a candidate cast by the qualified voters of the City voting in said election, and therefore, no candidate was elected at said election for the office of Member of Council for Place 5, but that a second or run-off election will be necessary in

order that the candidate receiving the highest number of votes shall have received a majority of all the votes cast for the office for which he was a candidate, and said run-off election is hereby ordered to be held on Saturday, April 16, 1983. The two candidates receiving the highest number of votes for such place in the election shall again be voted for at the second or run-off election.

SECTION 4. This canvass did not include the District 7 Council Election for Member of City Council, Place No. 7, and no declaration is made relative thereto, pending a recheck and comparison of the vote cast as requested by Mr. Frank Sepeda, which recheck is hereby authorized.

SECTION 5. Payment of all expenses incurred in connection with the holding of said election and run-off election are hereby authorized to be made out of the General Fund.
