AND RESCHEDULING ALL JULY 2009 CITY COUNCIL-RELATED

WHEREAS, a special City Council meeting is necessary to canvass the returns of the June 13, 2009 run-off election, and to swear in successful candidates who will immediately take office; and

WHEREAS, special meetings are also necessary to discuss and negotiate the FY 2010 City budget, and to reschedule all July 2009 Council meetings, including all Council Committee meetings during that month; **NOW THEREFORE:**


SECTION 3. All Council Committee meetings for July 2009 are rescheduled, to resume upon Council Committee Assignments by the Mayor.


