

AN ORDINANCE 2011-11-17-0938

SELECTING PAPE DAWSON ENGINEERS, INC. FOR NEGOTIATION AND EXECUTION OF A PROFESSIONAL SERVICES AGREEMENT FOR CIVIL ENGINEERING SERVICES IN THE AMOUNT NOT TO EXCEED \$ 600,000.00 FOR THE ESPADA ROAD PROJECT LOCATED IN COUNCIL DISTRICT 3 IN CONNECTION WITH THE 2007 BOND SAVINGS PROJECTS.

WHEREAS, in May 2007, the voters of San Antonio approved a \$550 million Bond Program to address a wide array of public infrastructure throughout the City, from street and drainage improvements, new sidewalk construction, bridge replacements, traffic upgrades, new libraries and improvements to existing City-owned facilities; and

WHEREAS, Ordinance No. 2011-05-19-0398 was approved by City Council which reallocated approximately \$47 million in savings and added Lord Road, Espada Road, Goliad Drainage, Roosevelt Drainage and Hausman Road Street/Drainage Projects to the Program; and

WHEREAS, services to be provided on this Project will include, but are not limited to the design of reconstructing and widening of Espada Road; and

WHEREAS, this Ordinance selects **Pape Dawson Engineers, Inc.** and authorizes negotiation and execution of a Professional Services Agreement for civil engineering service in an amount not to exceed \$600,000.00 for the Espada Road Project; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. **Pape Dawson Engineers, Inc.** is hereby selected for negotiation and execution of a Professional Services Agreement for civil engineering service for the Espada Road Project.

SECTION 2. The City Manager or her designee is hereby authorized to negotiate and execute a Professional Services Agreement with **Pape Dawson Engineers, Inc.** in an amount not to exceed \$600,000.00 for the Espada Road Project.

SECTION 3. Payment in the amount not to exceed \$600,000.00 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00246, Espada Road - IH 410 to Ashley Road, is authorized to be encumbered and made payable to **Pape Dawson Engineers, Inc.** for engineering services.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager, or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.




