PROJECT SHEET #1: FIRE STATION No. 99

PROJECT DESCRIPTION:	Design and construction of a new 12,000 SF fire station. The facility includes three bays to accommodate up to four fire apparatus vehicles and one emergency medical service vehicle. The new fire station is located on the northwest side of San Antonio adjacent to UTSA.		
PROJECT DETAILS AND ROLE OF SUBMITTING FIRM:	<ul style="list-style-type: none"> ◆ Walters & Associates (W&A) was the Prime Design Consultant for this project and performed architectural, engineering and interior design services along with assisting the City in bidding the project for the construction phase. ◆ The facility has a masonry veneer exterior and a steel frame structure. Foundations consist of angled concrete pilings and spread footings with a slab on grade concrete floor. Specialized designs interfacing the automated exhaust systems, overhead coiling doors, and signalization system were developed to reduce equipment damage and increase indoor air quality in the three apparatus bays. The station is a comprehensive facility with support areas, kitchen, dining, administrative, communications center, exercise/storage areas, and sleeping quarters. ◆ W&A developed and prepared the working drawings (including electrical and mechanical details) and specifications necessary for construction of the project. Following the final approval of the Construction Documents, W&A assisted City staff with preparation of the construction bid documents. ◆ W&A successfully worked with the San Antonio Fire Department and CIMS Department to achieve compatibility in the project design features and needs of the Fire Department.


