

AN ORDINANCE 2010-03-18-0223

REAPPOINTING MUNICIPAL COURT FULL-TIME JUDGES FOR
A NEW TERM EFFECTIVE MAY 1, 2010 TO APRIL 30, 2012.

* * * * *

WHEREAS, the Municipal Court Advisory Committee is charged, by Ordinance No. 2007-05-31-0595, with providing recommendations to the City Council; and

WHEREAS, the Committee has conducted a review of the performance of each full-time judge and recommends that each judge be reappointed to a new two year term ; and

WHEREAS, the City Council finds that the judicial candidates meet all requirements to be full-time municipal court judges and that it is in the best interest of the City to approve the recommendations of the Committee to reappoint those judges to a new term of office; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council approves the recommendation of the Municipal Court Advisory Committee to reappoint the following full-time judges for a two-year term, effective May 1st, 2010 to April 30, 2012, with the same salary and benefits previously established: Linda H. Conley, Daniel Guerrero, James Daniel Kassahn, Christine Dauphin Lacy, Robert F. Lipo, Jr., Carla Obledo, Alfredo M. Tavera and Peter Andrew Zamora.

SECTION 2. Funding for this Ordinance is available in Fund 11001000, Cost Center 0301010001, General Ledger 5101010. The amounts will be encumbered upon issuance of a purchase order, and payment is authorized to various personnel. All expenditures will be in accordance with the Fiscal Year 2010 budget approved by City Council.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Chief Financial Officer (CFO), City of San Antonio. The CFO may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific cost centers and fund numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective on May 1st, 2010.


