

AN ORDINANCE

2011-06-23-0597

**AUTHORIZING THE SETTLEMENT OF THE CLAIM FILED BY
ALEXANDER PEREZ FOR THE AMOUNT OF \$150,000.00 PAID FROM
THE SELF INSURANCE LIABILITY FUND.**

WHEREAS, on February 4, 2010, Alexander Perez was injured when accidentally run over by a City of San Antonio vehicle; and

WHEREAS, Alexander Perez alleges injuries resulting from the accident; and

WHEREAS, although the City of San Antonio has vigorously contested liability in this matter, it feels it is in its best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the parties have reached a settlement agreement for the amount of \$150,000.00, contingent upon City Council approval; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$150,00.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund and General Ledger 5402530 General Liability Claims, Cost Center 1009020001 Risk Management-Liability, and is authorized to be made payable as follows: \$150,000.00 will be paid to claimant Alexander Perez.


SECTION 2. The financial allocations in this ordinance are subject to approval by the Chief Financial Officer (CFO), City of San Antonio. The CFO, may subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific accounts, cost centers, or fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 3. This ordinance shall be effective on the tenth (10th) day after passage hereof.

PASSED and APPROVED this 23rd day of June, 2011.




