

AN ORDINANCE 2014 - 08 - 21 - 0601

**AUTHORIZING THE ACCEPTANCE OF SUPPLEMENTAL FUNDS IN AN AMOUNT UP TO \$312,764.00 FROM THE ALAMO AREA COUNCIL OF GOVERNMENTS FOR THE SENIOR NUTRITION PROGRAM FOR THE PERIOD OF OCTOBER 1, 2013 TO SEPTEMBER 30, 2014.**

**WHEREAS**, the City's Senior Nutrition Program (SNP) provides approximately 2,800 meals daily, Monday through Friday, and nutritional information to seniors, ages 60 and older, at 63 senior centers, throughout the City; and

**WHEREAS**, the Department of Human Services operates the program using General Funds and federal funds awarded from the Texas Department of Aging and Disability Services through the Alamo Area Council of Governments; and

**WHEREAS**, the overall SNP budget, including funds proposed to be accepted in this ordinance, is \$5,584,190.00 of which 35% is funded through the SNP grant and 65% through the General Fund; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee, or the Director of the Department of Human Services (DHS) or her designee, is authorized to accept supplemental funds in an amount up to \$312,764.00 from the Alamo Area Council of Governments (AACOG) for the Senior Nutrition Program for the period of October 1, 2013 to September 30, 2014. The City Manager or her designee, or the Director of DHS or her designee, is further authorized to execute all necessary documents to effectuate acceptance of the additional funding. A copy of the original grant application is on file with DHS.

**SECTION 2.** Upon acceptance, fund 2601138015 entitled SNP 2014 is hereby designated for use in the accounting for the fiscal transaction in the acceptance of these funds, and the sum of up to \$312,764.00 from AACOG will be appropriated in said fund. The revised budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.



**SECTION 4.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


