

A RESOLUTION 2013-03-21-0012R

**DIRECTING THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT - CITY DESIGN CENTER TO WORK WITH CPS ENERGY STAFF TO DEVELOP POWER POLE AND ASSOCIATED INFRASTRUCTURE PLACEMENT STANDARDS FOR THE LONE STAR COMMUNITY PLAN AREA.**

**WHEREAS**, the San Antonio Master Plan Polices adopted May 29, 1997 recommends that the City preserve, protect, and enhance the integrity, economic viability, and livability of San Antonio's neighborhoods and encourage development of the Downtown area as a complete neighborhood to enhance its image to both visitors and residents; and

**WHEREAS**, the SA2020 Final Report acknowledged by resolution on May 10, 2012 recommends that the City increase Downtown housing units by 5,000 and increase Downtown employment by 13,775 employees by 2020; and

**WHEREAS**, Centro Partnership San Antonio developed a Strategic Framework Plan for the Center City that sets out key goals, targets, and strategies to achieve the SA2020 vision for Downtown, and

**WHEREAS**, the Center City Implementation Plan adopted June 21, 2012 recommends that the City implement the Strategic Framework Plan by increasing public investment, creating a housing finance strategy, coordinating management, and regulating development by undertaking master planning for key center city growth areas; and

**WHEREAS**, the Lone Star Community Plan, adopted as a component of the City's Comprehensive Master Plan on March 21, 2013, is the master plan for the *Near River South* growth area and provides a balanced approach to redevelopment that was developed through a community-based public participation process; and

**WHEREAS**, the above described action is an implementation strategy included in the Lone Star Community Plan; **NOW THEREFORE;**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**Section 1.** The City Council hereby directs the Department of Planning and Community Development - City Design Center to work with CPS Energy staff to develop power pole and associated infrastructure placement standards for the Lone Star Community Plan area.


**Section 2.** This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


