That the City Manager be and is hereby authorized to enter into a contract of insurance with Associated Aviation Underwriters, Metropolitan Casualty Insurance Company, Policy No. FBL 7 - 128 for bodily injury and property damage liability on premises at Stinson Field and International Airport for the period from January 15, 1955 to January 15, 1956.

2. That the sum of \$1022.03 be and is hereby appropriated out of the 1954 General Fund - Account No. 56-04-01 in payment to Associated Aviation Underwriters, Metropolitan Casualty Insurance Company on said insurance evidenced by Associated Aviation Underwriters, Metropolitan Casualty Insurance Company Policy No. FBL 7 - 128 for the period from January 15, 1955 to January 15, 1956.
