APPOINTING PAUL TALAMANTEZ, JR. AND ROBERTO VASQUEZ AS MUNICIPAL COURT JUDGES FOR TERMS ENDING AUGUST 31, 2001; AS REQUESTED BY COUNCILMAN RAUL PRADO, AS CHAIRMAN OF THE MUNICIPAL COURT COMMITTEE.

WHEREAS, the City of San Antonio is required by the Texas Government Code, Section 30.00224(b) to provide by Charter for the appointment or election of municipal judges; and

WHEREAS, Section 112 of the City Charter provides that the City Council shall appoint the judges of Municipal Court for two year terms; and

WHEREAS, the City Council Municipal Court Committee has considered applications for appointment of two full-time judges to Municipal Court to fill unexpired terms and has submitted its recommendations to the City Council; and

WHEREAS, the City Council wishes to appoint Paul Talamantez, Jr. and Roberto Vasquez as full-time Municipal Court Judges, such appointments to take effect on June 3, 2001; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following persons are hereby appointed as new full-time judges of Municipal Court for terms effective June 3, 2001 and ending on August 31, 2001:

Paul Talamantez, Jr.
Roberto Vasquez

Such new full-time appointments shall provide for all authority, compensation and benefits as the City Council has previously established and that current full-time judges of Municipal Court now hold and receive.
