BE IT ORDAINED BY THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:-

1. That Section 7 of an ordinance entitled "AN ORDINANCE ORDERING THE CITY CLERK TO PLACE THE NAME OF G. M. ROPER, AS CANDIDATE FOR THE OFFICE OF COMMISSIONER OF POLICE AND FIRE OF THE CITY OF SAN ANTONIO, ON OFFICIAL BALLOT FOR SECOND OR RUN-OFF ELECTION, TO BE HELD IN THE CITY OF SAN ANTONIO, ON THE 22ND DAY OF MAY, 1951", passed and approved by the Commissioners on the 11th day of May, 1951, be and the same is amended hereby so that the same shall hereafter read as follows:

"7. That paper ballots shall be used for casting of votes at said run-off or second election to be held in the City of San Antonio on May 22, 1951 and absentee voting in connection therewith, in accordance with the laws of the State of Texas and the Charter and Ordinances of the City of San Antonio in such cases made and provided."
